The Company has granted the Underwriters (as defined below) an option (the "Over-Allotment Option"), exercisable, in whole or in part, by Beacon (as defined below), on behalf of the Underwriters, at any time and from time to time up to 30 days following the Closing Date (as defined below), to purchase up to an additional number of Units (the "Additional Units") equal to 15% of the Units sold pursuant to the Offering at a price per Additional Unit equal to the Issue Price to cover overallotments, if any, and for market stabilization purposes. All references herein to the "Offering" shall be deemed to include the Over-Allotment Option and all references herein to the "Units" shall be deemed to include the Additional Units. For certainty, the Over-Allotment Option shall be exercisable for Additional Units, Warrants, or Common Shares (or any combination thereof).

The net proceeds from the Offering will be used for working capital and general corporate purposes.

Rule 144(a)(3) under the 1933 Act).
