On July 2, 2013, the Offeror acquired an aggregate of \$408,000 of convertible debenture. These debentures can be converted in common shares of St-Georges Platinum and Base Metals Ltd. ("St-Georges") at a **minimum conversion price** of \$0.10 per share. When added to its existing shareholdings of St-Georges (which consisted of an aggregate of 2,554,922 common shares), the Offeror's total, post-exercise holdings of common shares **would be** of 6,634,922 common shares, representing 32.9% of the **then** 20,012,606 common shares issued and outstanding. (15,932,606 current with the addition of the newly created common shares due to the conversion of the debentures at a price of \$0.10 for 4,080,000 new common shares and a new total of 20,012,606).
