On March 25, 2024, St-Georges, an insider of the Corporation, disposed a total of 3,108,000 Shares (the “Disposed Shares”) on the public market (the “Disposition”).

The Disposed Shares represent approximately 7.28% of the issued and outstanding Shares of the Corporation on non-diluted basis. Prior to the date of the Disposition, St-Georges held 11,384,519 Shares of the Corporation.
