Pursuant to the operating agreements of RCP23, LLC and GTI II, LLC (collectively, the "Investor LLCs"), which are registered shareholders of the Issuer, 9,317,745 Subordinate Voting Shares and 61,893 Super Voting Shares of the Issuer were distributed to members of the Investor LLCs (the "Investor LLC Distributions"). Immediately prior to the Investor LLC Distributions, the Investor LLCs converted certain Super Voting Shares into Multiple Voting Shares and Multiple Voting Shares into Subordinate Voting Shares in order to distribute Subordinate Voting Shares to such members of the Investor LLCs on June 26, 2020. Following these transactions, GTI II, LLC ceased to be a shareholder of the Issuer.

Prior to the Investor LLC Distributions, the Acquiror, together with his joint actors including the Investor LLCs, held beneficial ownership or control or direction over 270,655 Super Voting Shares, which represented approximately 69.3% of the class, 140,419 Multiple Voting Shares, which represented approximately 59.2% of the class, and 99,249 Subordinate Voting Shares, which represented less than 0.1% of the class. Each Super Voting Share carries 1,000 votes and is convertible into one Multiple Voting Share and each Multiple Voting Share carries 100 votes and is convertible into 100 Subordinate Voting Shares (each of which carries one vote).

Following the Investor LLC Distributions, the Acquiror, together with his remaining joint actors, hold beneficial ownership or control or direction over 238,059 Super Voting Shares, which represent approximately 61.3% of the class, 49,448 Multiple Voting Shares, which represent approximately 39.0% of the class, and 126,493Subordinate Voting Shares, which represent less than 0.1% of the class.

As part of the Investor LLC Distributions, the Acquiror and its joint actors, ceased to have control over some of the Issuer's securities previously held by the Investor LLCs. See items 1.2 and 3.1.

In addition, the Acquiror holds (i) 50,000 stock options of the Issuer exercisable to acquire 50,000 Subordinate Voting Shares at an exercise price of C\$14.64 per share until August 29, 2028, of which 16,666 stock options vested on August 29, 2019, 16,667 stock options expected to vest on August 29, 2020 and 16,667 stock options expected to vest on August 29, 2021; (ii) 25,000 restricted share units ("**RSUs**") of the Issuer expected to vest on August 30, 2020; (iii) 66,667 RSUs of which 33,333 RSUs are expected to vest on April 12, 2021 and 33,334 RSUs are expected to vest on April 12, 2022; (iv) 300,000 stock options of the Issuer exercisable to acquire 300,000 Subordinate Voting Shares at an exercise price of C\$12.07 per share until July 26, 2024 of which 100,000 are expected to vest on each of July 26, 2020, July 26, 2021 and July 26, 2022, respectively; and (v) 81,521 stock options of the Issuer exercisable to acquire 81,521 Subordinate Voting Shares at an exercise price of C\$9.22 per share until March 25, 2025 of which 27,173 are expected to vest on March 25, 2021 and 27,174 are expected to vest on each of March 25, 2022 and March 25, 2023, respectively.

In addition, the Acquiror beneficially owns or controls warrants to purchase (i) 234 Subordinate Voting Shares at an exercise price of C\$14.03 per share that expire on May 21, 2025; (ii) 1,004 Subordinate Voting Shares at an exercise price of C\$12.04 per share that expire on November 9, 2024; and (iii) 5,018 Subordinate Voting Shares at an exercise price of C\$19.39 per share that expire on May 22, 2024.

The Investor LLC Distributions had no impact on such holdings.

The management of GTI II, LLC is controlled by the Acquiror. The interests of GTI II, LLC are owned by a number of parties, including the Acquiror.

In connection with the Super Voting Shares, the Acquiror and joint actors and certain other parties previously entered into a coattail agreement. The coattail agreement contains certain restrictions on the transfer of the Super Voting Shares in order to provide the other shareholders of the Issuer with certain rights in the event of a transaction that would have constituted a take-over bid, if the Super Voting Shares had been Multiple Voting Shares or Subordinate Voting Shares.
