GENIUS ABANDONS REÏVA AND ANNOUNCES THE RESIGNATION OF THREE DIRECTORS AND ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER

Octobre 28, 2014 – Montreal, Quebec – Genius Properties Ltd. (the "Corporation" or "Genius") (CSE: GNI) and 9191364 Canada Inc (« 9191364 ») agree to terminate and resolve the rollover agreement of the "Reïva" assets that was entered into in May 2015.

9191364 surrenders and transfers to Genius for cancellation the 30 million common shares of Genius issued as consideration in the context of the agreement. Consequently, the Company shall transfer to 9191364 all assets purchased under the rollover agreement.

9191364 assumes and bears accounts payable of certain suppliers and 9191364 agrees to indemnify and save harmless the Company from any claim or damage of any kind whatsoever with respect to accounts payable directly connected to Reïva.

In addition, the Company announces that Mr. Denis Richard resigned from his position as President and Chief Executive Officer and as Director.

The Company is pleased to announce the appointment of Mr. Stéphane Leblanc as President and Chief Executive to replace Mr. Richard, effective immediately. Mr. Leblanc is an entrepreneur with over 12 years of experience. He participated in activities of all aspects from sales and marketing, public relations, communications, corporate finance; including strategic advisory services, mergers and acquisitions, raising private capital, savings (Initial Public Offerings and RTO), listing on the Toronto Stock Exchange, Canadian Stock Exchange, OTC and other international exchanges.
