The requirement to file this report was triggered on August 16, 2017 when the Acquiror, indirectly through 9248-7792 Québec Inc. ("9248-7792"), disposed of 400,000 Shares in the open market through the facilities of the CSE at an average price of \$0.15 per Share for an aggregate consideration of \$61,430.30 (the "Disposition").

As a result of the Disposition, the Acquiror became a holder of less than 10% of the outstanding securities of the Issuer requiring this filing under National Instrument 61-103 – The Early Warning System and Related Take-Over Bid and Insider Reporting Issues.
