On May 19, 2020, pursuant to a non-brokered private placement (the "**Private Placement**"), ESG acquired ownership of 6,000,000 Units at a price of \$0.015 per Unit. Each Unit consists of one Share and one Warrant. Each Warrant is exercisable into Shares of King at an exercise price of \$0.05 per Share until May 19, 2022.

ESG's common shares are listed for trading on the TSX Venture Exchange under the symbol "ESGW". Nick Watters, a director of ESG, is also a director of King. He currently holds no controlling interest in either entity.

As a result of the closing of the Private Placement, ESG holds, on a non-diluted basis, a total of 9,619,000 Shares representing 8.90% of King's issued and outstanding Shares and, on a diluted basis, ESG would hold a total of 15,619,000 Shares, representing approximately 14.46% of King's issued and outstanding Shares., should all of the Warrants be exercised
