On May 31, 2021, 2021, 2176423 Ontario acquired (the "**Acquisition**") ownership of 15,384,616 Units of the Corporation at a price of \$0.065 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.085 per Share until three years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

obtained and any other requirements of the TSX Venture Exchange ("**TSXV**") have been satisfied, the Warrants will only be exercised by 2176423 Ontario to the extent that Shares issued upon such exercise would not result in him becoming a "control person" (as such term is defined in the policies of the TSXV) of the Corporation. Mr. Sprott understands that the Corporation has agreed to call a shareholders meeting on or before September 26, 2021 to recommend and seek such approval.
