

Khan Announces Approval of Stock Option Grant

TORONTO, ONTARIO, Canada, February 15, 2013 – Khan Resources Inc. ("**Khan**" or the "**Company**") (CNSX:KRI) is pleased to announce that a total of 1,675,000 stock options to purchase common shares of Khan were granted to employees, officers and directors yesterday at an exercise price of \$0.20 per share and expiring on February 14, 2016. The grant is subject to regulatory approval.

Under Khan's stock option plan (the "**Stock Option Plan**"), 9.58% of the issued and outstanding common shares or 6,528,334 common shares are reserved for issuance, including the above grant, and the Company may grant an additional 284,210 options under the Stock Option Plan representing 0.42% of the issued and outstanding common shares.
