Item 4. Summary of Material Changes:

The Company announced that it intends to complete a non-brokered private placement offering of up to 13,333,333 units ("**Units**") of the Company at a price of C\$0.15 per Unit (the "**Offering**") raising gross proceeds of up to C\$2,000,000.

Item 5. Full Description of Material Change:

The Company announced that it intends to complete a non-brokered private placement offering of up to 13,333,333 Units of the Company at a price of C\$0.15 per Unit raising gross proceeds of up to C\$2,000,000. Each Unit consists of one common share (a "**Common Share**") of the Company and one half of one common share purchase warrant (each whole warrant, a "**Warrant**"), with each Warrant entitling the holder to purchase one Common Share at an exercise price of C\$0.25 for a period of 24 months from the date of issuance. The offering is expected to close on January 15, 2021.

The Company intends to use the net proceeds from the Offering to make potential follow-on investments in certain of its current portfolio companies, invest in new private companies in the blockchain and privacy sector, as well as increase its holdings in select cryptocurrencies.

The completion of the Offerings will provide the Company with funds to to make potential followon investments in certain of its current portfolio companies, invest in new private companies in the blockchain and privacy sector, as well as increase its holdings in select cryptocurrencies.

The Offering is considered a related party transaction within the meaning of 61-101 as a director and officer (the "**Insider**") of the Company intends to acquire an aggregate of 2,000,000 Units pursuant to the Offering. Such related party transaction is exempt from the formal valuation and minority shareholder approval requirements of MI 61-101 as neither the fair market value of securities being issued to the related parties nor the consideration being paid by the related parties exceeded 25% of the Company's market capitalization.

Prior to the completion of the Offering, Mr. Guoga held, directly or indirectly 14,894,500 Common Shares, 3,000,000 Warrants and 1,000,000 stock options. Upon closing of the Offering, Mr. Guoga will hold an aggregate of 16,894,500 Common Shares, representing approximately 14.9% of the issued and outstanding Common Shares on an undiluted basis, 4,000,000 Warrants and 1,000,000 stock options. In the event that Mr. Guoga exercises his Warrants and stock options, he would hold an aggregate of 21,894,500 Common Shares, or approximately 18.4% of the issued and outstanding Common Shares of the Company, on a partially diluted basis.
