Mr. Docherty is a director and the President & CEO of the Issuer.

On March 27, 2018, the Issuer issued 1,200,000 Deer Horn Shares to Docherty Capital Inc., a private company wholly-owned by Mr. Docherty, at a deemed price of \$0.10/share in consideration for the settlement of \$120,000 debt owed to Mr. Docherty.

Prior to this current share issuance, Mr. Docherty owned or controlled 666,790 Deer Horn Shares representing approximately 7% of the outstanding Deer Horn Shares.

Upon completion of this current share issuance, Mr. Docherty now has ownership or control over an aggregate of 1,866,790 Deer Horn Shares, representing approximately 14% of the outstanding Deer Horn Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 200,000 stock options owned or controlled by Mr. Docherty), Mr. Docherty would have ownership and control over approximately 15% of the then issued Deer Horn Shares.
