MANAGEMENT'S DISCUSSION AND ANALYSIS

The following information, prepared as of May 26, 2015, should be read in conjunction with the unaudited condensed interim financial statements of Dynamic Oil and Gas Exploration Inc. ("the Company" or "Dynamic") for the three months ended March 31, 2015, together with the audited financial statements of the Company for the year ended December 31, 2014 and the accompanying Management's Discussion and Analysis (the "MD&A") for that fiscal year. The referenced financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board applicable to the preparation of interim financial statements, including IAS 34, Interim Financial Reporting. All amounts are expressed in Canadian dollars unless otherwise indicated.

COMPANY DESCRIPTION

Dynamic Oil & Gas Exploration Inc. was incorporated under the Alberta Business Corporations Act on November 23, 2004. The Company's main activities during the three months ended March 31, 2015 have been maintaining its public listing and pursuing potential business opportunities as they arise. The Company is listed on the TSX Venture Exchange's NEX board under the trading symbol "DME.H".

RESULTS OF OPERATIONS

The Company recorded a loss of \$29,626 (\$0.00 per share) for the three months ended March 31, 2015 as compared to a loss of \$254,876 (\$0.00 per share) for the three months ended March 31, 2014. The table below details certain non-cash or unusual transactions that for the purposes of this discussion have been adjusted out of the reported loss for the three months ended March 31, 2015 and 2014 to produce an adjusted loss that forms a better basis for comparing the period over period operating results of the Company.

Comments regarding certain of these items are as follows:

- Foreign exchange loss is based on fluctuations in the exchange rate between the Canadian dollar and the US dollar. Certain liabilities are denominated in US dollars.
- Share-based payments reported in 2014 is a result of the Company granting 3,000,000 stock options at a fair value of \$0.069 per option as determined using the Black-Scholes option pricing model. The options vested immediately.

The decrease in adjusted loss recorded in the three months ended March 31, 2015 as compared to the three months ended March 31, 2014 is the net result of changes to a number of expenses. Of note are the following items:

- Accounting and audit (\$2,780 vs. \$8,600) decreased as the Company reduced activity during the three months ended March 31, 2015.
- Legal fees (\$nil vs. \$21,065) are comprised of general legal fees and fees relating to potential transactions. During the three months end March 31, 2015 the Company incurred no legal expenses due to limited activity.
- Office and miscellaneous expenses (\$11,179 vs. \$34,762) decreased due to reduced travel and filing fees during the three months ended March 31, 2015.

The increase in the loss for the quarter ended March 31, 2014 was due to share-based payments expense of \$172,182 as a result of the Company granting 3,000,000 stock options.

The increase in loss for the quarter ended June 30, 2013 was due to the assignment of \$400,000 of debt from BidCactus, LLC. The Company was pursuing a potential transaction with BidCactus, LLC during the years ended December 31, 2013 and 2012. On June 3, 2013 the Company and BidCactus, LLC entered into a termination agreement, mutually agreeing to terminate the asset purchase agreement.

The decrease in loss for the quarter ended September 30, 2013 was due to recording a gain on forgiveness of debt of \$29,631.

LIQUIDITY AND CAPITAL RESOURCES

The Company's operations consumed approximately \$26,426 of cash (before working capital items) for the three months ended March 31, 2015. The Company's aggregate operating, investing, and financing activities during the three months ended March 31, 2015 resulted in a decrease in its cash balance from \$46,585 at December 31, 2014 to \$20,159 at March 31, 2015. The Company's working capital deficiency at March 31, 2015 was \$17,791 compared to working capital of \$11,627 at December 31, 2014.

The Company has no long-term debt.

FINANCING ACTIVITIES AND CAPITAL EXPENDITURES

During the three months ended March 31, 2015 and 2014 the Company had no financing activities or capital expenditures.

Credit Risk

Credit risk arises from cash held with banks and financial institutions. The maximum exposure to credit risk is equal to the carrying value of the financial assets. The Company's cash is primarily held with the Bank of Montreal.

Interest Rate Risk

Interest rate risk is the risk that the future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The risk that the Company will realize a loss is limited because at present the Company's liabilities are non-interest bearing or have fixed interest rates.

Liquidity Risk

Liquidity risk is the risk that the Company is not able to meet its financial obligations as they become due. The Company manages its liquidity risk by continuously monitoring forecasted and actual cash flows, as well as anticipated investing and financing activities. At March 31, 2015 the Company had a working capital deficiency of \$17,791.
