## MANAGEMENT'S DISCUSSION AND ANALYSIS

The following information, prepared as of April 29, 2016, should be read in conjunction with the financial statements of Dynamic Oil & Gas Exploration Inc. (the Company or Dynamic) for the year ended December 31, 2015. The referenced financial statements have been prepared in accordance with International Financial Reporting Standards (IFRS). All amounts are expressed in Canadian dollars unless otherwise indicated.

The loss for the year ended December 31, 2015 and 2014 decreased as the Company focused on preserving capital and limiting expenses.

## RESULTS OF OPERATIONS

The Company recorded a loss of \$82,093 (\$0.00 per share) for the year ended December 31, 2015 as compared to a loss of \$447,020 (\$0.01 per share) for the year ended December 31, 2014. The table below details certain non-cash or unusual transactions that for the purposes of this discussion have been adjusted out of the reported loss for the year ended December 31, 2015 and 2014 to produce an adjusted loss that forms a better basis for comparing the year over year operating results of the Company.

Comments regarding certain of these items are as follows:

- Foreign exchange loss is based on fluctuations in the exchange rate between the Canadian dollar and the US dollar. Certain liabilities are denominated in US dollars.
- Share-based payments reported in 2014 is a result of the Company granting 3,000,000 stock options at a fair value of \$0.069 per option as determined using the Black-Scholes option pricing model. The options vested immediately.

The decrease in adjusted loss recorded in the year ended December 31, 2015 as compared to the year ended December 31, 2014 is the net result of changes to a number of expenses. Of note are the following items:

- Consulting fees (\$20,000 vs. \$79,290) decreased as the Company reduced activity during the year ended December 31, 2015.

- Legal fees (\$nil vs. \$46,321) are comprised of general legal fees and fees relating to potential transactions. During the year ended December 31, 2015 the Company incurred no legal expenses due to limited activity.
- Office and miscellaneous expenses (\$38,827 vs. \$80,178) decreased due to reduced travel and filing fees during the year ended December, 2015.

## FOURTH QUARTER

The Company recorded a loss of \$17,198 (\$0.00 per share) for the three months ended December 31, 2015 as compared to a loss of \$68,608 (\$0.00 per share) for the three months ended December 31, 2014. The decrease in loss during the current period was due to a reduction in consulting and legal fees.

The increase in the loss for the quarter ended March 31, 2014 was due to share-based payments expense of \$206,589 as a result of the Company granting 3,000,000 stock options.

## LIQUIDITY AND CAPITAL RESOURCES

The Company's operations consumed approximately \$81,300 of cash (before working capital items) for the year ended December 31, 2015. The Company's aggregate operating, investing, and financing activities during the year ended December 31, 2015 resulted in a decrease in its cash balance from \$46,585 at December 31, 2014 to \$2,353 at December 31, 2015. The Company's working capital deficiency at December 31, 2015 was \$69,704 compared to working capital of \$11,627 at December 31, 2014.

The Company has no long-term debt.

## FINANCING ACTIVITIES AND CAPITAL EXPENDITURES

The Company had no financing activities or capital expenditures during the year ended December 31, 2015 and 2014.

## Credit Risk

Credit risk arises from cash held with banks and financial institutions. The maximum exposure to credit risk is equal to the carrying value of the financial assets. The Company's cash is primarily held with the Bank of Montreal.

## Interest Rate Risk

Interest rate risk is the risk that the future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The risk that the Company will realize a loss is limited because at present the Company's liabilities are non-interest bearing or have fixed interest rates.

## Liquidity Risk

Liquidity risk is the risk that the Company is not able to meet its financial obligations as they become due. The Company manages its liquidity risk by continuously monitoring forecasted and actual cash flows, as well as anticipated investing and financing activities. At December, 2015 the Company had a working capital deficiency of \$69,704.

## **CHANGES IN ACCOUNTING POLICIES INCLUDING INITIAL ADOPTION**

There were no pronouncements issued by the IASB or the IFRS Interpretations Committee that are mandatory for accounting periods beginning before or on January 1, 2015 that are expected to have a material impact on the Company.

## **ACCOUNTING STANDARDS ISSUED BUT NOT YET EFFECTIVE**

The following new standards have been issued but are not yet effective:

### IFRS 9 Financial Instruments

The IASB has issued a new standard, IFRS 9, Financial Instruments (~~IFRS 9~~), which will ultimately replace IAS 39, ~~Financial Instruments: Recognition and Measurement~~ (~~IAS 39~~). The replacement of IAS 39 is a multi-phase project with the objective of improving and simplifying the reporting for financial instruments and the issuance of IFRS 9 is part of the first phase of this project. IFRS 9 uses a single approach to determine whether a financial asset or liability is measured at amortized cost or fair value, replacing the multiple rules in IAS 39. For financial assets, the approach in IFRS 9 is based on how an entity manages its financial instruments in the context of its business model and the contractual cash flow characteristics of the financial assets. IFRS 9 requires a single impairment method to be used, replacing multiple impairment methods in IAS 39. For financial liabilities measured at fair value, fair value changes due to changes in an entity's credit risk are presented in other comprehensive income. Companies may early adopt IFRS 9 however there is no mandatory application date. The Company does not expect the implementation to have a significant impact on the Company's results of operations, financial position and disclosures.

## **OUTLOOK**
