1. ORGANIZATION AND NATURE OF OPERATIONS AND GOING CONCERN

Dynamic Oil & Gas Exploration Inc. (%Dynamic+or the %Company+) was incorporated under the Alberta Business Corporations Act on November 23, 2004. The Companys main activities during the six months ended June 30, 2016 were maintaining its public listing and pursuing potential business opportunities as they arise. The Company is listed on the TSX Venture Exchanges NEX board under the trading symbol %DME.H+. The Companys head office is located at Suite 200, 550 Denman Street, Vancouver, BC.

These condensed interim financial statements have been prepared assuming the Company will continue as a going concern, which contemplates the realization of assets and satisfaction of liabilities in the normal course of business. At June 30, 2016, the Company had accumulated losses of \$15,792,734 since its inception and expects to incur further losses in the development of its business. For the six months ended June 30, 2016 the Company experienced a loss of \$78,815 and used \$82,231 of cash in operations before non-cash working capital items. These factors indicate a material uncertainty that casts significant doubt upon the Companys ability to continue as a going concern and, therefore, that it may be unable to discharge its liabilities in the normal course of business.

Management has determined that the Company will not have enough cash on hand to continue operations for the next twelve months. The continuation of the Company is dependent upon obtaining necessary financing to meet its ongoing levels of corporate overhead.

While management has been successful in securing financing in the past, there can be no assurance it will be able to do so in the future or that financing will be available on terms which are acceptable to the Company. These condensed interim financial statements do not give effect to any adjustments to the amounts and classifications of assets and liabilities which might be necessary should the Company be unable to continue its operations as a going concern.

2. BASIS OF PRESENTATION

These condensed interim financial statements have been prepared in accordance with International Financial Reporting Standards (%FRS+) as issued by International Accounting Standards Board (%ASB+) applicable to the preparation of interim financial statements, including IAS 34, Interim Financial Reporting. The condensed interim financial statements should be read in conjunction with the annual financial statements for the year ended December 31, 2015, which have been prepared in accordance with IFRS as issued by IASB.

The Company uses the same accounting policies and methods of computation as in the annual financial statements for the year ended December 31, 2015. These condensed interim financial statements were approved by the board of directors for use on August 26, 2016.

During the year ended December 31, 2014 the Company discontinued its stock option plan. Such discontinuance did not adversely affect the rights of any Optionee under the options granted pursuant to the stock option plan. The exercise price of options granted is greater than or equal to the market price of the Companys shares on the date of the grant. The options are for a maximum term of five years. All options vest on the date of grant, unless otherwise indicated.
