#### LIQUIDITY AND CAPITAL RESOURCES

The Companys operations consumed \$82,231 of cash (before working capital items) for the six months ended June 30, 2016. The Companys aggregate operating, investing, and financing activities during the six months ended June 30, 2016 resulted in an increase in its cash balance from \$2,353 at December 31, 2015 to \$3,409 at June 30, 2016. The Companys working capital deficiency at June 30, 2016 was \$148,200 compared to a working deficit of \$69,704 at December 31, 2015.

The Company has no long-term debt.

#### FINANCING ACTIVITIES AND CAPITAL EXPENDITURES

The Company had no financing activities or capital expenditures during the six months ended June 30, 2016 and 2015.

#### **Credit Risk**

#### **Interest Rate Risk**

Interest rate risk is the risk that the future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The risk that the Company will realize a loss is limited because at present the Company liabilities are non-interest bearing or have fixed interest rates.

# **Liquidity Risk**

Liquidity risk is the risk that the Company is not able to meet its financial obligations as they become due. The Company manages its liquidity risk by continuously monitoring forecasted and actual cash flows, as well as anticipated investing and financing activities. At June 30, 2016 the Company had a working capital deficiency of \$148,200.
