#### 1. Name and Address of Issuer

## 2. Parties to the Transaction

The Issuer (previously Darien Business Development Corp.), 1197027 B.C. Ltd ("B.C. Subco"), Vireo Health, Inc. ("Vireo"), Vireo Finco (Canada) Inc. ("Canadian Finco") and Darien Merger Sub, LLC ("U.S. Subco").

# 3. Description of the Transaction

On February 13, 2019, the Issuer, B.C. Subco, Vireo, Canadian Finco and U.S. Subco entered into a business combination agreement pursuant to which, amongst other things, Vireo completed a reverse takeover of the Issuer and the business of Vireo became the business of the Issuer ("Business Combination"). The Business Combination was structured as a series of transactions, including a Canadian three-cornered amalgamation transaction. Prior to the completion of the Business Combination, the Issuer changed its name from "Darien Business Development Corp." to "Vireo Health International, Inc.", restructured its share capital to, among other things, re-designate its existing common shares as subordinate voting shares, and create a new class of multiple voting shares and a new class of super voting shares.

#### 4. Effective Date of the Transaction

The transaction was completed on March 18, 2019.

# 5. The Name of Each Party, if any, that Ceased to be a Reporting Issuer after the Transaction and of Each Continuing Entity

The Issuer continued to be a reporting issuer. No party ceased to be a reporting issuer.

# 6. Change in Financial Year End and Date of the Reporting Issuer's First Financial Year-End Subsequent to the Transaction

The Issuer's new financial year end is December 31. The first financial year-end of the Issuer following the completion of the Business Combination is December 31, 2019.
