On October 1, 2020, the Linton Family Trust (2040) (the “**Linton Family Trust**”) sold an aggregate of 495,000 Shares (the “**October Disposition**”). In addition, previously in July and August 2020, the Linton Family Trust sold an aggregate of 746,742 Shares (together with the October Disposition, the “**Dispositions**”). Mr. Linton is the trustee of The Linton Family Trust (2040).

The Linton Family Trust.

Immediately prior to the Dispositions, Mr. Linton beneficially owned, and exercised control or direction over, 1,736,715 Shares and an aggregate of 16,736,715 Share

purchase warrants, representing approximately 4.65% of the issued and outstanding Shares on a non-diluted basis and approximately 34.16% of the issued and outstanding Shares on a partially-diluted basis, assuming the exercise of the warrants held by Mr. Linton. Accordingly, Mr. Linton's interest in the Shares decreased by 2.30% on a partially diluted basis.

Mr. Linton disposed of beneficial ownership of the Shares. See item 2.2 above.

Immediately following the Dispositions, Mr. Linton beneficially owns, and exercises control or direction over, 494,973 Shares and an aggregate of 16,736,715 Share purchase warrants, representing approximately 1.33% of the issued and outstanding Shares on a non-diluted basis and approximately 31.87% of the issued and outstanding Shares on a partially-diluted basis, assuming the exercise of the warrants held by Mr. Linton.
