CALGARY, ALBERTA – Maple Leaf Green World Inc. (“**Maple Leaf**” or the “**Company**”) (**NEO: MGW, OTCQX: MGWFF**) announces the voting results from its annual general meeting of shareholders held on September 27, 2019 in Calgary, Alberta. A total of 34,631,616 common shares of Maple Leaf (“**Common Shares**”) were represented at the meeting, being 21.49% of the Company’s issued and outstanding Common Shares.
