This Management's Discussion & Analysis ("MD&A") is intended to help the reader understand the Sweet Earth Holdings Corporation (the "Company") financial statements. The information provided herein should be read in conjunction with the Company's audited financial statements for the year ended June 30, 2024, the condensed interim consolidated financial statements for the three months ended September 30, 2024 ("Financial Statements") and related notes attached thereto which have been prepared in accordance with International Financial Reporting Standards ("IFRS"). Except as otherwise disclosed, all dollar figures in this report are stated in Canadian dollars ("CAD"). The effective date of this report is November 29, 2024.

Management is responsible for the preparation and integrity of financial statements, including the maintenance of appropriate information systems, procedures and internal controls and to ensure that information used internally or disclosed externally is complete and reliable. The Company's board of directors follows recommended corporate governance guidelines for public companies to ensure transparency and accountability to shareholders. The board's audit committee meets with management on a quarterly basis to review financial statements and MD&As, and to discuss other financial, operating and internal control matters.

The financial statements of the Company are prepared on a consolidated basis to include the financial information of the Company's wholly-owned subsidiaries, TSN Agricorp Ltd., Sweet Earth (deconsolidated in September 2024), LLC (deconsolidated in December 2023), Sweet Earth Holdings Corp. S.L.(dissolved in December 2022) and Sweet Earth Colombia S.A.S.(operations did not commence).

On May 19, 2020, the Company completed a reverse takeover transaction ("RTO") of Seaway Energy Services Inc., the effective of which was to become a listed entity on the Canadian Securities Exchange ("CSE") under the ticker symbol SE.

Statements in this report that are not historical facts are forward-looking statements involving known and unknown risks and uncertainties, which could cause actual results to vary considerably from such statements. DESCRIPTION OF BUSINESS AND OVERVIEW

Sweet Earth Holdings Corporation (the "Company") was incorporated as 1168061 B.C. Ltd. under the Province of British Columbia Business Company Act on June 13, 2018. The name was changed to Sweet Earth Holdings Corporation on July 26, 2018, to reflect the Company's strategic decision to focus the business on becoming a major hemp cannabidiol ("CBD") cultivator and processor. During the fiscal year ended June 30, 2021, the Company changed its focus of operations that maintains a full line of hemp and CBD products for the US and global market.

Effective December 31, 2023, the Company is no longer operating in the CBD business sector. The company is actively shifting its strategic direction to better align with evolving market demands and emerging opportunities. Creating shareholder value is at the core of the company's strategic initiatives as it navigates new business opportunities.

In September 2024, both TSN and LLC were dissolved.

On October 17, 2024, the Company closed a non-brokered private placement of common shares in the capital of the Company at \$0.017 per share by the issuance of 12,000,000 shares for gross proceeds of \$204,000.

On November 26, 2024, the Company announced it intends to consolidate the common shares in the capital of the company on the basis of one post-consolidation common share for 10 pre-consolidation common shares.

Future Plans & Market Outlook

Management has been working to grow its business and maintain its listing requirements with the CSE. The Company continues to move forward with developing new business opportunities that will increase its revenue. The current condition of the hemp segment has declined significantly over the past several quarters and the Company is looking to find new opportunities in all sectors of industry.

RESULTS OF OPERATIONS

This review of the results of operations should be read in conjunction with the Company's condensed interim consolidated financial statement for the period ended September 30, 2024.

Financial Results

For the period ended September 30, 2024

The Company's revenue from operations for the period ended September 30, 2024, was (2023 - 4, 275) and the gross profit was (2023 - 3, 492).

For the period ended September 30, 2024, the Company net loss was \$29,563 (2023 - \$40,399). The net loss is comprised of a gross profit on sales of \$nil (2023 - \$3,492), net operating costs of \$nil (2023 - \$5,579), administrative expenses of \$29,563 (2023 - \$32,875) and other net losses of \$nil (2023 - \$7,524).

For the period ended September 30, 2024, net operating costs of \$nil (2023 - \$5,579) which was for utilities which decreased from the previous year due to the termination of operations in December 2023.

For the period ended September 30, 2024, administrative expenses of \$29,563 (2023 - \$30,788) consisted of interest on loans of \$2,837 (2023 - \$nil), management fees of \$15,750 (2023 - \$16,125), office and general expenses of \$4,920 (2023 - \$9,990), and professional fees of \$6,056 (2023 - \$4,135). The total administrative expenses during the period were comparable to last year.as the company continues to reorganize, restructure and explore other corporate opportunities.

For the period ended September 30, 2024, significant other items of \$nil (2023 - \$7,524) primarily consisted of loss for impairment of property and equipment of \$nil (2023 - \$7,981) and gain on termination of lease liabilities of \$nil (2023 - \$457).

LIQUIDITY, FINANCING AND CAPITAL RESOURCES

As at September 30, 2024, the Company had a cash balance of \$10,635 (June 30, 2023 - \$17,703) to settle current liabilities of \$327,389 (June 30, 2023 - \$304,894). The Company expects to fund these liabilities and its operational activities and through the issuance of capital stock and, or through operational revenues over the coming year.

As at September 30, 2024, the Company's cash used in operating activities was \$37,068 (2023 - \$23,271), and cash from financing activities was \$30,000 (2023 - \$nil).

During the period ended September 30, 2024, cash used in operating activities was 37,068 (2023 –23,271). Cash used during the period consists primarily of net loss of 29,563 (2023 – 40,399), less adjustments for accrued interest on loans of 1,148 (2023 - 1,1

During the period ended September 30, 2024, cash provided by financing activities was \$30,000 (2023 - \$nil) was from loans received.

RELATED PARTY TRANSACTIONS

The Company considers officers and members of the Board of Directors as related parties. Key Management costs for the period ended September 30, 2024 is \$15,750 (2023 - \$16,125). Due to related parties represents fees due to officers and directors at September 30, 2024 of 36,750 (June 30, 2024 – 21,000). The amounts are non-interest bearing, due on demand and bear no specific terms of repayment.

FINANCIAL INSTRUMENTS

International Financial Reporting Standards establishes a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy has the following levels:

Level 1 - quoted prices (unadjusted) in active markets for identical assets or liabilities;

Level 2 - inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices); and

Level 3 - inputs for the asset or liability that are not based on observable market data (unobservable inputs).

Financial risks

The Company has exposure to the following risks from its use of financial instruments:

- Credit risk
- Liquidity risk
- Market risk

Credit risk

The Company's credit risk is primarily attributable to cash and receivables. The Company has no significant concentration of credit risk arising from operations. Cash consists of chequing account at reputable financial institution, from which management believes the risk of loss to be remote. Federal deposit insurance covers balances up to \$100,000 in Canada. Financial instruments included in receivables consist of amounts due from government agencies. At September 30, 2023, management considers the Company's exposure to credit risk is minimal.

Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due. The Company has a planning and budgeting process in place to help determine the funds required to support the Company's normal operating requirements on an ongoing basis. The Company ensures that there are sufficient funds to meet its short-term business requirements, considering its anticipated cash flows from operations and its holdings of cash.

As at September 30, 2024, the Company had a cash balance of \$10,635 (June 30, 2024 - \$17,703) to settle current liabilities of \$327,389 (June 30, 2024 - \$304,894). So far, the Company's sole source of funding has been the issuance of equity securities. The Company's access to financing is always uncertain. There can be no assurance of continued access to significant equity funding.

Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices.

a) Interest and foreign exchange risk

The Company is subject to normal risks including fluctuations in foreign exchange rates and interest rates. While the Company manages its operations in order to minimize exposure to these risks, it has not entered into any derivatives or contracts to hedge or otherwise mitigate this exposure. The Canadian dollar equivalent of the amounts denominated in foreign currencies at June 30, 2024 and September 30, 2024 are as follows:

b) Price risk

The Company is exposed to price risk with respect to equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market. The Company is not currently subject to price risk as it is not listed on a public stock exchange.

FUTURE ACCOUNTING POLICY CHANGES

A number of new standards, amendments to standards and interpretations are not yet effective as of the date of this report and were not applied in preparing the audited financial statements. None of these are expected to have a material effect on the financial statements of the Company.

CAPITAL COMMITMENTS

The Company has no commitments for equipment expenditures for 2024. The Company has forecasted that any property and equipment expenditures based on future needs will be funded from working capital and/or from operating or capital leases.

CRITICAL ACCOUNTING ESTIMATES

The preparation of the Company's consolidated financial statements in conformity with IFRS requires management to make judgments, estimates and assumptions that affect the reported amounts of assets, liabilities and contingent liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Estimates and assumptions are continuously evaluated and are based on management's experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. However, actual outcomes can differ from these estimates.

Management must make significant judgments or assessments as to how financial assets and liabilities are categorized. The following are the critical estimates and judgments that management has made in applying the Company's accounting policies and that have the most significant effect on the amounts recognized in the consolidated financial statements:

a) Going concern

The assessment of the Company's ability to execute its strategy by funding future working capital requirements involves judgment. Estimates and assumptions are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

b) Functional currency

The functional currency of an entity is the currency of the primary economic environment in which the entity operates. The functional currency of the Company is the Canadian dollar, which is also the reporting currency of the Company. The functional currency determinations were conducted through an analysis of the consideration factors identified in International Accounting Standards ("IAS") 21. An entity considers the following factors in determining the functional currency of entities under its control:

- i) the currency that mainly influences sales prices for goods and services,
- ii) the currency of the country whose competitive forces and regulations mainly determine the sales prices of its goods and services, and
- iii) the currency that mainly influences labour, material and other costs of providing goods or services.

The Company has determined that the function currency of TSN and LLC is the US dollar.

c) *Estimated useful life and residual value of equipment*

The calculation of depreciation involves estimates concerning the economic life and salvage value of equipment.

d) Fair value of share-based payments

The fair value of share-based payments is calculated using a Black-Scholes option-pricing model. There are a number of estimates used in the calculation such as the future forfeiture rate, expected option life and the future price volatility of underlying security, which can vary from actual future events. The factors applied in the calculation are management's best estimate based on historical information and future forecasts.

e) Leases

The Company applies judgement to determine whether an arrangement contains a lease. The evaluation requires the Company to determine whether a contract conveys the right to direct the use of an identified asset, the supplier has a substantive substitution right, the Company has the right to obtain substantially all of the economic benefits from use of the asset throughout the period and whether renewal options are reasonably certain of being exercised. For those arrangements considered to be a lease, further judgement is required to determine the lease term and the rate implicit in the lease.

f) *Taxation*

The calculation of deferred taxes is based on a number of assumptions including estimating the future periods in which temporary differences, tax losses and other tax credits will reverse, the use of substantively enacted tax rates at the statements of financial position date and the likelihood of deferred tax assets being realized.

FUTURE ACCOUNTING POLICY CHANGES

A number of new standards, amendments to standards and interpretations are not yet effective as of the date of this report and were not applied in preparing the audited financial statements. None of these are expected to have a material effect on the financial statements of the Company.

OFF-BALANCE SHEET ARRANGEMENTS

There are no off-balance sheet arrangements.
