CLOSING OF NON-BROKERED PRIVATE PLACEMENT FINANCING

Vancouver, BC, Canada – Range Energy Resources Inc. (the “Company”) (CSE: RGO) (FWB: YGK) is pleased to announce that further to its news release dated **June 13, 2014**, it closed the non-brokered Private Placement for a total of **25,000,000** units (the “Units”) of the Company at a price of **CDN\$0.05** per Unit for gross proceeds of approximately **CDN\$1,250,000**.

The securities issued are subject to a **four (4)** month hold period that expires on **October 20, 2014**.

The capital from the Offering will be used by the Company to continue to fulfill its obligations to joint venture participants so that the development of the Khalakan Block in the Kurdistan Region of Iraq can continue as well as provide general working capital.
