The Early Warning System and Related Take-Over Bid and Insider Reporting Issues

(b) The designation and number or principal amount of securities and the offeror's securityholding percentage in the class of securities of which the offeror acquired ownership or control in the transaction or occurrence giving rise to the obligation to file the news release, and whether it was ownership or control that was acquired in those circumstances:

On November 14, 2014, the offeror acquired ownership of 30,000,000 Units (**Units**) for \$0.05 per Unit. Each Unit is comprised of one common share (**Common Share**) in the capital of Range Energy Resources Inc. (**Range**) and one common share purchase warrant (**Warrant**). Each Warrant entitles the offeror to acquire an additional Common Share at any time up to November 14, 2019 at a price of \$0.05 per Common Share. The transaction was completed by Range as a non-brokered private placement of 30,000,000 Units (the **Private Placement**), resulting in gross proceeds to Range of CDN\$1,500,000. Prior to the Private Placement, the offeror owned 340,127,272 Common Shares representing 61.84% of the issued and outstanding Common Shares of Range.

(c) The designation and number or principal amount of securities and the offeror's securityholding percentage in the class of securities immediately after the transaction or occurrence giving rise to the obligation to file the news release:

Following the acquisition on November 14, 2014, the offeror owns 370,127,272 Common Shares, representing 63.82% of the issued and outstanding Common Shares. In addition, the offeror has the right to acquire (pursuant to the terms of the Warrants acquired in the Private Placement and Warrants acquired by the offeror in October 2014, July 2014, June 2014, May 2014, November 2013 and March 2013) an additional 302,227,272 Common Shares for an aggregate of 672,354,544 Common Shares, which, if fully exercised would result in the offeror owning 76.21% of the issued and outstanding Common Shares.

The Units were acquired by way of a private placement.

The Units were issued at a price of \$0.05 per Unit for a total purchase price paid by the offeror of \$1,500,000.

- (f) The purpose of the offeror and any joint actors in effecting the transaction or occurrence that gave rise to the news release, including any future intention to acquire ownership of, or control over, additional securities of the reporting issuer:**

The offeror holds the Common Shares and Warrants for investment purposes and intends to evaluate their investment and to increase or decrease their holdings in Range as circumstances warrant.

- (g) The general nature and the material terms of any agreement, other than lending arrangements, with respect to securities of the reporting issuer entered into by the offeror, or any joint actor, and the issuer of the securities or any other entity in connection with the transaction or occurrence giving rise to the news release, including agreements with respect to the acquisition, holding, disposition or voting of any of the securities:**

The 30,000,000 Units were purchased by the offeror pursuant to the terms of the subscription agreement for the Private Placement. The offeror purchased the Units for \$0.05 per Unit, with each Unit consisting of one Common Share and one Warrant. Each Warrant held by the offeror entitles the offeror to acquire one additional Common Share for \$0.05 per Common Share.

- (h) The names of any joint actors in connection with the disclosure required by this report:**
