Item 5.1 Full Description of Material Change

Further to the Company’s news release dated **October 30, 2015**, it closed the second tranche of the non-brokered Private Placement for a total of **16,403,750** units (the “Units”) of the Company at a price of **CDN\$0.05** per Unit for gross proceeds of approximately **CDN\$656,150.00**.

Each Unit consists of **one (1)** common share and **one (1)** transferrable share purchase warrant. Each warrant entitles the holder thereof to purchase **one (1)** additional common share of the Company on or before **October 30, 2020** at a price of **CDN\$0.05** per common share.

The securities issued are subject to a **four (4)** month hold period that expires on **March 1, 2016**.

The capital from the Offering will be used by the Company to continue to fulfill its obligations to joint venture participants so that the development of the Khalakan Block in the Kurdistan Region of Iraq can continue as well as provide general working capital.
