Item 2 Parties to the Transaction

EnviroGold Global Limited (formerly, Range Energy Resources Inc.) (the "Company"), 2826847 Ontario Inc. ("Subco") and EnviroGold Global (CAN) Ltd. ("EGGL").

Item 3 Description of the Transaction

Name Change and Business Combination

Pursuant to an amalgamation agreement among EGGL, the Company, Subco, being a wholly-owned subsidiary of the Company, the business combination was completed by way of a three-cornered amalgamation (the "Amalgamation") pursuant to which EGGL amalgamated with Subco, and the Company acquired all the issued and outstanding common shares of EGGL (the "EGGL Shares") in exchange for its common shares ("Company Shares") on the basis of one Company Share for each EGGL Share then issued and outstanding, as a result of which the amalgamated company formed from the amalgamation of EGGL and Subco became a wholly-owned subsidiary of the Company and adopted the name "EnviroGold Private Limited" (the "RTO Transaction"). The Amalgamation also provides that all outstanding options, restricted share units and warrants to purchase EGGL Shares remain outstanding and now entitle the holders thereof to acquire equivalent securities of the Company in lieu of securities of EGGL on the same terms and conditions.

As a result of the RTO Transaction, the Company has 160,621,633 common shares outstanding, and has reserved common shares for issuance of up to (i) 1,794,200 upon exercise of finder warrants; and (iii) 14,683,252 upon exercise of stock options.

Effective July 16, 2021, the Company Shares began trading on the Canadian Securities Exchange under the symbol "NVRO".

Item 4 Effective Date of Transaction

The RTO Transaction was completed on July 14, 2021.

Item 5 Names of Each Party, if any, that Ceased to be an Issuer Subsequent to the Transaction and of each Continuing Entity

The Company continued as a reporting issuer after the RTO Transaction under the name EnviroGold Global Limited.
