Two news releases were issued and disseminated on December 13, 2018 and filed on SEDAR (<u>www.sedar.com</u>).

### Item 4: Summary of Material Changes

The Company announced that it has signed an agreement (the "**Agreement**") with Namaste Technologies Inc.'s ("**Namaste**") (TSXV: N) (FRANKFURT: M5BQ) (OTCMKTS: NXTTF) wholly-owned subsidiary, Cannmart Inc. ("**Cannmart**"), where Cannmart may purchase medical cannabis products from the Company's Propagation Services Canada ("**PSC**") greenhouse operations in Delta, BC, subject to approval of its cultivation and sales licenses by Health Canada.

The Company subsequently clarified the first news release. See Item 5 for details.

# Item 5: Full Description of Material Change

On December 13, 2018, the Company announced that it has signed an Agreement with Namaste wholly-owned subsidiary, Cannmart where Cannmart may purchase medical cannabis products from the Company's PSC greenhouse operations in Delta, BC, subject to approval of its cultivation and sales licenses by Health Canada.

In October 2018, the Company's majority-owned subsidiary, AAA Heidelberg, received a license to produce under Health Canada's Access to Cannabis for Medical Purposes Regulations for its facility in London, ON.

Subject to the terms of the Agreement, Cannmart reserves the right of first refusal to purchase up to 10% of the total annual production from the Company's large-scale Delta Greenhouse Complex, representing 25,000,000 grams, at a price of \$4 per gram, or up to \$100,000,000 per year. This Agreement is in-line with Namaste's vision to offer a diverse range of high-quality cannabis products in its online platform through Cannmart. Cannmart operates a medical cannabis sales-only license under the regulations of the Cannabis Act and purchases bulk cannabis products from a variety of licensed producers across the country to offer in its online platform.

The Company issued a subsequent news release to provide readers with additional information to the news release earlier on December 13, 2018, where the Company announced the signing of the Agreement with Cannmart where Cannmart may purchase medical cannabis products from the Company's PSC greenhouse operations in Delta, BC, subject to approval of its cultivation and sales licenses by Health Canada.

Subject to the terms of the Agreement, Cannmart reserves the right of first refusal to purchase up to 10% of the total annual production from the Company's large-scale Delta Greenhouse

Complex, representing 25,000,000 grams, at a price of \$4 per gram, or up to \$100,000,000 per year with production costs estimated to be between 20-24 percent of total revenue.

When the 2,200,000 sq. ft. Delta Greenhouse Complex is fully operational in 2021, it is projected to have an annual capacity of 250,000,000 grams of high-quality cannabis.
