The Company has completed the acquisition of all of the issued and outstanding shares of Pure Extract Technologies Inc. (“**Pure Extract**”) by way of a three-cornered amalgamation (the “**Transaction**”).

**Item 5. Full Description of Material Change**

**5.1 Full Description of Material Change**

On October 28, 2020, the Company completed its previously announced transaction with Pure Extract carried out by way of a three-cornered amalgamation between Pure Extract and 1270233 B.C. Ltd., the Company’s wholly owned subsidiary (the “**Transaction**”). The Company will carry on the business of Pure Extract, which holds a Standard Processing License under the *Cannabis Act* granted to it by Health Canada on September 25, 2020.

In connection with the Transaction, the Company changed its name to “Pure Extracts Technologies Corp.” and consolidated the common shares of the Company

(the “**Shares**”), on the basis of one (1) post-consolidation Share for every six (6) pre-consolidation Shares.

The Shares were delisted from the TSX Venture Exchange on October 27, 2020, and the Company anticipates that the Shares commenced trading on the Canadian Securities Exchange under the ticker symbol “PULL” on November 5, 2020.
