**Weststar Resources Closes First Tranche of Financing for \$323,000**

**Vancouver, BC – July 23, 2015:** Weststar Resources Corp. (CSE: WER) (the “Company”) is pleased to announce that the Company has closed a first tranche of a Non-Brokered Private Placement Financing (the “Private Placement”) for gross proceeds of \$323,000.
