

Trueclaim Exploration Inc. announces appointment of New Directors.

London, Ontario - Trueclaim Exploration Inc. (TSX-V: TRM, OTCQX: TRMNF.) is pleased to announce the appointment of two new directors to its board.

Mr. Troy Nikolai and Mr. Byron Coulthard have been appointed effective immediately.

Mr. Troy Nikolai brings over fourteen years' experience to TRM in accounting and auditing. Trueclaim has two primary properties; the former Gold producing Scadding Mine near Sudbury, Ontario; and the former Silver producing Black Diamond property near Globe, Arizona.

The Black Diamond Project has several sites with historical records showing high grade past Silver production. A recently discovered Copper-Silver-Gold anomaly that extends over a minimum 600M (1950 ft.) containing samples up to 9.39% copper, 3040g/t (88.6oz./t) silver and 2.87g/t (.084oz./t) gold has added an entirely new dimension to the potential of this property.

"With several major producing Copper mines in the immediate vicinity, we are anxious to test the continuity to depth of the high grade surface results discovered thus far" states John Carter Trueclaim's President. The Black Diamond property is currently awaiting its drill permit and Trueclaim has planned a program to test the results of its very successful field exploration. A comprehensive drill strategy is being planned for this fall.
