Northern Sphere Mining Corp. is pleased to announce it has completed its first pre-production processing run of material from its Arizona Silver Property. NSM successfully produced 143 ounces of Silver dore and over 200 ounces silver in concentrate which it is currently being smelted. The silver/gold/ copper bars were produced by gravity separation. The run of mine (ROM) consisted of approximately 800 lbs. of feed to the mill. Internal assays done in its onsite assay facility established the grade to be 500 ounces per ton. After gravity and smelting, it was determined the recovery to be approximately 80 %. NSM is currently preparing to commission its leach circuit which should increase recovery to over 95 %. Optimization tests are currently ongoing.
