Trueclaim Exploration Inc. is pleased to provide the following corporate update on its Arizona and Ontario Joint Ventures with Northern Sphere Mining Corp. (CSE: NSM).

NSM has, over the last few months, made significant strides forward as it moves to production at its 80-per-cent-owned Arizona silver property. NSM has:
