

Fandom Sports Media Corp. closes Private Placement for gross proceeds of \$883,000

Vancouver, British Columbia – April 27, 2017, FanDom Sports Media Corp. (CSE: FDM) (OTCQB: FDMSF) (FRANKFURT: TQ42) ("FanDom Sports" or the "Company") is pleased to announce that it has closed its private placement yesterday and raised gross proceeds of \$883,000 pursuant to the policies of the Canadian Securities Exchange (the "Exchange" or the "CSE"). FanDom will issue 17,660,000 Units (the "Units") at \$0.05 per Unit. Each Unit consists of one common share and one warrant. Each warrant is exercisable at \$0.10 per common share for two years from closing (the "Private Placement"). Three directors of the Company have subscribed for an aggregate of 3,200,000 Units for proceeds of \$160,000. All common shares and warrants issued pursuant to the Private Placement may not be transferred until August 27, 2017.

Proceeds of the Private Placement will be for general working capital purposes and accounts payable. An aggregate of 1,680,000 Units will be issued as Finder's Fees with the same terms as the private placement.
