The Creditor and the Issuer entered into a debt conversion agreement (the “**Debt Conversion Agreement**”) on August 7, 2020, pursuant to which the Creditor agreed to accept 1,800,000 Common Shares at a deemed issued price of \$0.05 per Common Share, in full settlement of \$90,000 of indebtedness owing to the Creditor by the Issuer (the “**Transaction**”). The Transaction closed on August 14, 2020.

The Creditor acquired 1,800,000 Common Shares of the Issuer, representing approximately 17.40% of the issued and outstanding Common Shares on a non-diluted basis. Prior to the completion of the Transaction, the Creditor owned 225,000 Common Shares of the Issuer. Upon completion of the Transaction, the Creditor will own 2,025,000 Common Shares of the Issuer, representing approximately 19.58% of the Issuer’s issued and outstanding Common Shares on a non-diluted basis.

Upon completion of the Transaction, the Creditor will own 2,025,000 Common Shares of the Issuer, representing approximately 19.58% of the issued and outstanding Common Shares on a non-diluted basis.

Item 4 – Consideration Paid

The Creditor received 1,800,000 Common Shares through the settlement of an aggregate of \$90,000 of indebtedness at a price of \$0.05 per Common Share.

The Creditor acquired 1,800,000 Common Shares of the Issuer at a price of \$0.05 per Common Share pursuant to a Debt Conversion Agreement for aggregate cash consideration of \$90,000.

The 1,800,000 Common Shares were acquired through the settlement of an aggregate of \$90,000 of indebtedness owed to the Creditor.

- (j) a solicitation of proxies from securityholders;
- (k) an action similar to any of those enumerated above.

The securities were acquired for investment purposes. The Creditor may, depending on market and other conditions, or as future circumstances may dictate, increase or decrease some or all of the existing or additional securities it holds or will hold, or may continue to hold its current position. The Creditor currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (j), above. Depending on market conditions, general economic and industry conditions, the Issuer's business and financial condition and/or other relevant factors, the Creditor may develop such plans or intentions in the future.

Pursuant to the terms of the Debt Conversion Agreement the Creditor agreed to accept 1,800,000 Common Shares at a deemed issued price of \$0.05 per Common Share, in full settlement of \$90,000 of indebtedness owing to the Creditor by the Issuer. The Transaction closed on August 14, 2020.
