Notice and Access: You are receiving this notice to advise that the proxy materials for the Meeting are available on the Internet as the Company has decided to use the notice and access model ("Notice and Access") under recent amendments to National Instrument 54-101 in order to reduce paper use and reduce the Company's printing and mailing costs. You must return your duly completed and executed proxy **before 10:00 am (Vancouver Time) on Friday, February 12, 2016,** or no later than forty-eight (48) hours (excluding Saturdays, Sundays and holidays) before the time of any adjourned or postponed Meeting.

Non-registered shareholders may vote by completing and submitting their voting instruction form as follows: (1) by telephone (call the toll free number indicated on the voting instruction form and follow the instructions), (2) on the internet (go to the website indicated on the voting instruction form and follow the instructions), or (3) by mail (complete the voting instruction form and return it in the envelope provided).
