**ACQUISITION OF SECURITIES  
OF FINEQIA INTERNATIONAL INC.**

Rangar Capital Limited (the “**Acquiror**”) announces that on October 28, 2016 the Acquiror acquired ownership and control of 20,850,000 units (“**Units**”) of Fineqia International Inc. (the “**Company**”) pursuant to a non-brokered private placement and 494,500 common shares of the Company (“**Common Shares**”) pursuant to a debt settlement transaction (collectively, the “**Transactions**”). Each Unit is comprised of one Common Share and one common share purchase warrant (a “**Warrant**”), with each Warrant entitling the holder to purchase one Common Share for a period of 5 years at an exercise price of CDN\$0.05 per Common Share. Accordingly, the Acquiror acquired ownership and control of 21,344,500 Common Shares and 20,850,000 Warrants in connection with the Transactions.

Immediately before the completion of the Transactions, the Acquiror owned and controlled 20,139,699 Common Shares and 16,496,869 common share purchase warrants of the Company collectively representing approximately 13.26% of the issued and outstanding Common Shares of the Company, assuming the exercise of the common share purchase warrants. Immediately after the completion of the Transactions, the Acquiror owns and controls an aggregate of 41,484,199 Common Shares and 37,346,869 common share purchase warrants of the Company collectively representing approximately 11.28% of the issued and outstanding common shares of the Company, assuming the exercise of the common share purchase warrants. Therefore, the Acquiror’s securityholding percentage in the issued and outstanding Common Shares decreased from 13.26% to 11.28%, assuming the exercise of the common share purchase warrants.

The Acquiror paid the Company total consideration of CDN\$208,500 in respect of the Units, representing CDN\$0.01 per Unit, and equivalent total consideration of CDN\$24,725 in respect of the Common Shares issued in connection with the debt settlement transactions, representing a deemed price of CDN\$0.05 per Common Share.

The Acquiror entered into the transaction for investment purposes. The Acquiror may increase or reduce its investment in the Company according to market conditions or other relevant factors.

The Acquiror was organized in the jurisdiction of Malta, its principal business is consulting and investment holdings and its head office is located at Suite 4, Level 2, Parklane Business Centre, Mountbatten Street, Hamrun, Malta. The head office of the Company is located at Suite 804 - 750 West Pender Street, Vancouver, British Columbia, V6C 2T7.

The Acquiror will file with the Canadian securities regulators within the prescribed period an early warning report providing details on the acquisition.
