**ACQUISITION OF SECURITIES  
OF FINEQIA INTERNATIONAL INC.**

Andrew John Scott Walton-Green (the "**Acquiror**") announces that on February 1, 2017, the Acquiror acquired ownership and control of 18,831,201 common shares (the "**Shares**") of Fineqia International Inc. (the "**Issuer**") pursuant to a debt settlement transaction (the "**Transaction**").

Immediately before the completion of the Transaction, the Acquiror owned and controlled 52,005,635 Shares and 30,205,000 common share purchase warrants (the "**Warrants**") of the Issuer collectively representing approximately 11.88% of the issued and outstanding Shares of the Issuer, assuming the exercise of the Warrants.

Immediately after the completion of the Transaction, the Acquiror owns and controls an aggregate of 70,836,836 Shares and 30,205,000 Warrants of the Issuer collectively representing approximately 14.60% of the issued and outstanding Shares of the Issuer, assuming the exercise of the Warrants. Therefore, the Acquiror's securityholding percentage in the issued and outstanding Shares increased from 11.88% to 14.60%, assuming the exercise of the Warrants.

The Acquiror entered into the Transaction for investment purposes. The Acquiror may increase or reduce its investment in the Issuer according to market conditions or other relevant factors.
