



Finore Mining Provides Bi-weekly Default Status Report

Vancouver, British Columbia – June 27, 2016. Further to the Management Cease Trade Order dated May 2, 2016 (the “MCTO”) issued under *National Policy 12-203 Cease Trade Orders for Continuous Disclosure Defaults* (“NP 12-203”) in respect of Finore Mining Inc. (CSE: FIN; OTCQX: FNREF) (the “Company” or “Finore”), the default announcement of the Company dated April 29, 2016 (the “Default Announcement”), and the subsequent bi-weekly default status reports issued on May 16, 2016, May 30, 2016 and June 13, 2016, the Company announces that it has recently closed the final tranche of a private placement to raise \$110,000 for working capital, that it has paid outstanding audit fees and that the Company’s auditor is in the process of completing the audit of the Company’s annual financial statements (the “Annual Statements”) for the fiscal year ended December 31, 2015.

The Company advises that it is delinquent in respect of the filing of interim financial statements for the quarter ended March 31, 2016 and related MD&A and certifications and that it anticipates filing the same within 2 weeks of when the Annual Statements are filed.

Pursuant to the MCTO, the Chief Executive Officer and the Chief Financial Officer of the Company may not trade in securities of the Company until such time as the Company files the Annual Statements, Management’s Discussion and Analysis (“MD&A”) in respect of the Annual Statements and related certifications, and the Executive Director of the British Columbia Securities Commission (the “BCSC”) revokes the MCTO. The MCTO does not affect the ability of other shareholders of the Company to trade their securities.

Other than as disclosed in this press release, there are no material changes to the information contained in the Default Announcement. The Company confirms that it intends to satisfy the provisions of section 4.4 of NP 12-203 and will continue to issue bi-weekly default status reports for so long as the Company remains in default of the financial statement filing requirements.
