On August 22, 2019, KS acquired, indirectly, ownership of an aggregate of 30,000,000 (the “**KS Shares**”) common shares (“**Common Shares**”) of Wolfpack Brands Corporation (“**Wolfpack**” or the “**Company**”) pursuant to debt settlement transactions with the Company. KS acquired the KS Shares indirectly through 25010812 Ontario Inc. (“**KS Holdco**”). KS Holdco is a company controlled by KS, director and CEO of Wolfpack. KS is filing this initial early warning report due to his indirect holdings of Common Shares being over 10%.

KS Holdco.

The 30,000,000 KS Shares represent approximately 18.66% of the issued and outstanding Common Shares on a non-diluted basis. This represents a change of 18.66% as prior to the transactions, KS did not own any Common Shares of Wolfpack.

KS acquired ownership, control and direction of the KS Shares.

The KS Shares were issued from treasury of the Company at a deemed price of \$0.02 per share in the settlement of approximately \$600,000 in debt, as invoiced.

The transactions described herein were made as part of a series of refinancing and balance sheet remedial transactions intended to restructure Wolfpack's outstanding indebtedness and improve its financial position for reporting purposes. Wolfpack has entered into a series of agreements with, among others, certain current and former directors and officers of Wolfpack to convert the outstanding indebtedness of Wolfpack to Common Shares of the Company.

While KS has no current plans or intentions that relate to or would result in the items listed in (a) through (k) above, depending on various factors including, without limitation, the Company's financial position, the price levels of the Common Shares of the Company, conditions in the securities markets and general economic and industry conditions, the Company's business or financial condition, and other factors and conditions KS may acquire or dispose of additional securities in the future, but has no current plans or future intentions to do so.

KS Holdco has entered into a call option agreement dated June 1, 2019 that grants certain persons, including Richard Buzbuzian and Tony Di Benedetto, directors of the Company, an option to purchase the KS Shares in the event that certain performance objectives of Wolfpack have not been met by the second anniversary of said call option agreement.
