AXE MAKES AN UPDATE ON ITS INTENTION TO EVALUATE NEW BUSINESS OPPORTUNITIES

Laval, Canada, November 6th, 2014 – **Axe Exploration Inc.** (TSX-V: AXQ) (the "**Corporation**") following April 9th press release announcing its intention to evaluate new business opportunities and eventually redirect its business to the medical marijuana and industrial hemp industries, Axe would like to make to following update:

- Although the company has looked at several projects, all remained in an embryonic stage.
- When management will have targeted a specific project, the Board will be notified and the project will be submitted to it for approval, before being submitted to the shareholders.
- The company is studying the possibility to apply for a license from Health Canada in order to become an authorized producer under the "Marijuana for Medical Purposes Regulations (MMPR)".
- In order to obtain a license for the cultivation and sale of marijuana for medical purposes, the company must demonstrate that it meets the requirements of Health Canada. Requirements with respect to infrastructure are very important and are explained in detail in the "MMPR".
- The company cannot establish a timeline and cost estimates, as no project has yet been targeted.
