A news release was disseminated on December 18, 2017 through the facilities of Stockwatch.

Item 4 Summary of Material Change

The Company announced that on December 12, 2017 the company's subsidiary, Biocurepharm Corporation ("BP Korea") entered into a land purchase agreement (the "Agreement") with Korea Land & Housing Corporation ("KLHC"), a state-run land and housing development company in Korea, for the acquisition of a 6,060m2 industrial usage parcel.

Item 5 Full Description of Material Change

On December 12, 2017, BP Korea entered into a land purchase agreement with KLHC. The acquisition cost for the land is KRW2,813,950,000 (the "Purchase Price") (approximately C\$3,317,647.05 utilizing an exchange rate of C\$0.001179/1KRW, Dec. 12, 2017, Bank of Canada). On the execution of the Agreement, BP Korea paid 10% of the Purchase Price, being KRW 281,395,500 (approximately CDN\$331,765). The balance of the Purchase Price is payable in six substantially equal installments of approximately KRW 422,000,000 (approximately CDN\$663,350) every six months commencing on Jun. 12, 2018 until Dec. 12, 2020.
