MANAGEMENT'S DISCUSSION AND ANALYSIS FOR THE THREE MONTHS ENDED FEBRUARY 28, 2021

This discussion and analysis of financial position and results of operation is prepared as at April 29, 2021 and should be read in conjunction with the unaudited condensed consolidated interim financial statements and the accompanying notes for the three months ended February 28, 2021, of Rockshield Capital Corp. ("Rockshield" or the "Company"). The following disclosure and associated financial statements are presented in accordance with International Financial Reporting Standards ("IFRS"). Except as otherwise disclosed, all dollar figures included therein and in the following management's discussion and analysis ("MD&A") are quoted in Canadian dollars. Additional information relevant to the Company's activities can be found on SEDAR at www.sedar.com.

COVID-19

During March 2020 the World Health Organization characterized COVID-19 as a pandemic. COVID-19 has had a material adverse impact on global economies. In order to combat the spread of COVID-19 governments worldwide, including Canada, have enacted emergency measures including travel bans, legally enforced or self-imposed quarantine periods, social distancing and business and organization closures.

Determining the impact of COVID-19 on the valuation of the Company's investment portfolio required significant judgement given the amount of uncertainty regarding the long-term impact of COVID-19. The ultimate impact of COVID-19 on the financial results of the Company will depend on future developments, including the duration and spread of the pandemic and related advisories and restrictions. These developments and the impact of COVID-19 on the financial markets and the overall economy are highly uncertain and difficult to predict. If the financial markets and/or the overall economy are impacted for a period significantly longer than currently implied by the markets, the financial results of the Company, including the fair value of its corporate investments, may be materially adversely affected.

Company Overview

The Company was incorporated under the provisions of the B.C. Business Company Act on October 23, 2007. The Company's common shares trade on the Canadian Securities Exchange ("CSE") with the trading symbol of "RKS", on the OTCBB under the symbol "RKSCF" and the Frankfurt Stock Exchange under the symbol "6BC". The Company is a reporting issuer in British Columbia, Alberta and Ontario. The Company's principal office is located at #1305 - 1090 West Georgia Street, Vancouver, British Columbia, V6E 3V7.

Since 2014 the Company has focused on providing venture capital funding to early stage seed investments and investment in marketable securities, focusing on high growth sectors. As a junior venture capital firm and merchant bank, the Company is subject to risks and challenges similar to other companies in a comparable stage. These risks include, but are not limited to, dependence on key individuals, investment risks, market risks, illiquid securities and the ability to maintain adequate cash flows. See also "COVID-19".

On April 23, 2021 the Company entered into a binding letter of intent to assume the contractual rights to acquire various equity interests in a number of companies operating in the plant-based food market as described in "Proposed Investment".

Investment Portfolio

The Company's investments in marketable securities include common shares and other equity instruments of Canadian and U.S. companies that are listed on various Canadian stock exchanges or the OTCBB in the United States of America. The majority of the marketable securities instruments are shares of companies in the mining, energy, financial technology, medical technology and cannabis industries. The Company also holds investments in common shares of private companies which plan to publicly list their shares. In January 2021 the Company announced that it had updated and amended its investment policy by broadening the spectrum of investments to include plant-based foods, food alternatives and vegan-friendly alternatives. As of the date of this MD&A, no investments have been made in these sectors.

Management has designated its investments in common shares and warrants of publicly traded companies as "investments in equity/debt instruments" with the change in fair value recognized in profit or loss. The carrying values of the common shares have been directly referenced to published price quotations in an active market. The carrying values of equity and debt investments in unlisted private companies are valued at fair value using non-discernible market inputs based on specific company information and general market conditions. The carrying values of the unlisted warrants are valued at fair value using the Black-Scholes option pricing model.

The Company has been actively managing its investment portfolio. During the three months ended February 28, 2021 the Company made investment purchases totalling \$nil (February 29, 2020 - \$600,372) and sold certain of its investment portfolio for proceeds totalling \$1,211,334 (February 29, 2020 - \$278,552), recognizing a loss of \$172,040 (February 29, 2020 - \$509,342). In addition, the Company recorded unrealized gain of \$1,480,305 (February 29, 2020 - loss of \$421,868) on investments held.

As at February 28, 2021 the carrying value of the investment portfolio was \$1,589,202 (November 30, 2020 - \$1,492,271), with an accumulated unrealized holding gain of \$1,480,305 (November 30, 2020 - gain of \$273,239).

Proposed Investment

On April 23, 2021 the Company entered into a binding letter of intent ("LOI") with Novel Agri-Technologies Inc. ("Novel") pursuant to which the Company will assume Novel's contractual rights to acquire 100% of two, and 75% of a third, private arm's length plant-based food companies (combined the "Target Companies").

Under the terms set out in the LOI the Company will issue up to 85,000,000 common shares (the "Consideration Shares") of the Company and provide a total cash consideration of \$3,000,000 to the shareholders of the Target Companies and Novel, with \$1,000,000 payable now (the "Initial Payment") and the remaining \$2,000,000 payable on closing (the "Closing") of the acquisitions of the Target Companies (the "Acquisition"). In the event the Acquisition is not completed \$750,000 of the Initial Payment will be converted to a three-year term loan to Novel bearing interest at a rate of 8% per annum. The Company has paid \$250,000 of the Initial Payment. It is anticipated

that Novel will receive at Closing a profits interest in the Target Companies convertible into its respective share of the Consideration Shares.

The completion of the Acquisition is subject to the negotiation of definitive acquisition agreements with each of the Target Companies, which shall include customary closing conditions. Finder' fees are payable in connection with the Acquisition. No change of control of the Company will result from the Acquisition. Further deferred considerations are payable in shares or cash at the Company's election.

The Company's plant-based investment is to develop a seed-to-market operation that includes raw ingredients, processing, pulse fractionation, unique IP, and premium consumer packaged goods. Combining these three proven and complementary companies through a series of strategic investments provides Rockshield with industry-leading management in Novel and achieves the first phase of the Company's entrance into the rapidly expanding global plant-based foods market.

One of the Targeted Companies' crops include dried peas, fava beans, lentils and chickpeas; and processing through processes such as fractionation and extrusion creates the main proteins used in the majority of plant-based products on the market today. Examples of this include, Beyond Meat, Impossible Foods, and the largest ingredient supplier in the world, Ingredion, and many of the other companies' products.

The acquisitions of the Target Companies establishes Nutrition One, a completely vertically integrated seed-to-market division of the Company providing investors with significant exposure to the entire plant-based value chain. From raw ingredients to CPG products, the Company's investments in the Target Companies will combine three industry-leading companies to create one global brand to compete with the largest vertically integrated plant-based companies existing today.

After completing the acquisitions, one of the targets will operate under the name Prairie Plant Farms Ltd. ("Prairie Plant"), and the two other targets will operate as The Healthy Table Superfoods Inc. ("Healthy Table").

Results of Operations

Three Months Ended February 28, 2021 Compared to Three Months Ended November 30, 2020

During the three months ended February 28, 2021 ("Q1/2021") the Company reported net income of \$517,170 compared to net income of \$26,581 for the three months ended November 30, 2020 ("Q4/2020"), an increase in income of \$490,589. The increase in income is primarily due to the recognition of an unrealized gain on investments held of \$1,480,305 during Q1/2021 compared to \$63,527 during Q4/2020 and offset against the recognition of share based compensation of \$697,062 in Q1/2021 compared to a recovery of share-based compensation of \$27,006 in Q4/2020.

Three Months Ended February 28, 2021 Compared to the Three Months Ended February 28, 2020

During Q1/2021 the Company reported net income of \$517,170 compared to a net loss of \$1,004,023 for the three months ended February 29, 2020 ("Q1/2020"), an increase in income of \$1,521,193. The increase in income was primarily attributed the Company recording an unrealized gain on investments held of \$1,480,305 during Q1/2021 compared to an unrealized loss of \$421,868 during Q1/2020 and a realized loss of \$172,040 during Q1/2021 on the sale of investments compared to a loss of \$509,342 during Q1/2020 resulting in a total increase in income of \$2,239,475. This increase was partially offset by a \$712,991 increase in expenses from \$84,060 during Q1/2020 to \$797,051 during Q1/2021. Specific fluctuations in expenditures are as follows:

- (i) during Q1/2021 the Company recorded share-based compensation of \$697,062 (Q1/2020 \$27,097);
- (ii) during Q1/2021 the Company incurred directors and officers compensation \$20,872 (Q1/2020 \$29,343). See "Related Party Disclosures" for details;
- (iii) during Q1/2021 the Company incurred audit costs of \$27,500 compared to \$nil for Q1/2020 as a result of the timing of billings for the audit of the Company's year-end financial statements;
- (iv) during Q1/2021 the Company incurred legal fees of \$18,659 (Q1/2020 \$nil) for corporate matters and preparation of the LOI with Novel; and
- (v) during Q1/2021 the Company incurred \$15,874 (Q1/2020 \$nil) for professional fees for assistance in listing on the Depository Trust Company eligibility.

During the Q1/2021 the Company generated interest income of \$6,642 (Q1/2020 - \$10,970) which was attributed to interest from demand deposits held.

Financing Activities

During Q1/2021 the Company completed a non-brokered private placement of 40,000,000 units for proceeds of \$3,000,000. The net proceeds will be used by the Company to finance continuing making acquisitions and investments pursuant to the Company's investment policy, including investments in emerging industries, public and private equities or debt. In addition the Company issued 200,000 common shares for \$30,000 on the exercise of warrants.

No financing activities were conducted by the Company during O1/2020.

Investment Activities

During Q1/2021 the Company made investment purchases totalling nil (Q1/2020 - 600,372) and sold certain of its investments for proceeds of 1,211,334 (Q1/2020 - 278,552). See also "Investment Portfolio".

Financial Condition / Capital Resources

During Q1/2021 the Company recorded net income of \$517,170 and, as at February 28, 2021, had working capital of \$9,257,347. Any investment decisions made by the Company will be dependent on its cash, investment portfolio and working capital situation at the time. The Company anticipates that it has sufficient funds to manage its investments and make additional investments over the next twelve months as opportunities arise. The Company may complete other opportunities which may entail significant expenditures and, as a result, the Company may be required to obtain additional financing or sell its investments as required. However, the investments are comprised of common shares in early-stage development and the share prices are often volatile and there may be limited liquidity. See also "Proposed Investments".

The Company has no off-balance sheet arrangements.

The Company's risk exposures and the impact on the Company's financial instruments are summarized below:

Fair Value

The fair values of the Company's financial assets and liabilities approximates the carrying amounts either due to their short-term nature or because the interest rates applied to measure their carrying amount approximate current market rates.

Financial instruments measured at fair value are classified into one of three levels in the fair value hierarchy according to the relative reliability of the inputs used to estimate the fair values. The three levels of the fair value hierarchy are:

- Level 1 Quoted prices are available in active markets for identical assets or liabilities as of the reporting date. Active markets are those in which transactions occur in sufficient frequency and value to provide pricing information on an ongoing basis.
- Level 2 Pricing inputs are other than quoted prices in active markets included in Level 1. Prices in Level 2 are either directly or indirectly observable as of the reporting date. Level 2 valuations are based on inputs including quoted forward prices for commodities, time value and volatility factors, which can be substantially observed or corroborated in the market place.
- Level 3 Valuations in this level are those with inputs for the asset or liability that are not based on observable market data.

The recorded amounts for advance receivable and accounts payable and accrued liabilities approximate their fair value due to their short-term nature. The recorded amounts for cash and investments approximate their fair value. The fair value of cash, amounts receivable and investment in common shares under the fair value hierarchy is measured using Level 1 and Level 3 inputs.

Credit Risk

Credit risk is the risk of loss associated with a counterparty's inability to fulfill its payment obligations. The Company's credit risk is primarily attributable to cash and amounts receivable. Management believes that the credit risk concentration with respect to financial instruments included in cash and amounts receivable is remote.

Liquidity Risk

Liquidity risk is the risk that the Company will not have the resources to meet its obligations as they fall due. The Company manages this risk by closely monitoring cash forecasts and managing resources to ensure that it will have sufficient liquidity to meet its obligations. All of the Company's financial liabilities are classified as current and are anticipated to mature within the next fiscal period. The following table is based on the contractual maturity dates of financial assets and the earliest date on which the Company can be required to settle financial liabilities.

Market Risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates and commodity and equity prices. These fluctuations may be significant.

(a) Interest Rate Risk

The Company is exposed to interest rate risk to the extent that the cash and demand deposits bear floating rates of interest. The interest rate risk on cash and on the Company's obligations, are not considered significant.

(b) Equity Price Risk

The Company holds investments in publicly traded equity securities. Market prices for equity securities are subject to fluctuation and consequently the amount realized in the subsequent sale of an investment may significantly differ from the reported market value.

(c) Concentration Risk

As at February 28, 2021, \$1,296,057 of the Company's portfolio of investments was held in one company. This investment represents approximately 82% of the Company's investment portfolio and poor performance in the market price of this investment could adversely affect the Company's results.

Capital Management

The Company manages its capital structure and makes adjustments to it, based on the funds available to the Company, in order to support its investment. The Board of Directors does not establish quantitative return on capital criteria for management, but rather relies on the expertise of the Company's management to sustain future development of the business. The Company defines capital that it manages as share capital. The Company will continue to assess new investment opportunities as they arise and if it has adequate financial resources to do so. Management reviews its capital management approach on an ongoing basis and believes that this approach, given the relative size of the Company, is reasonable. There have been no changes to the Company's approach to capital management during the three months ended February 28, 2021 or fiscal 2020. The Company is not subject to any externally imposed capital requirements.

Changes in Accounting Policies

There are no changes in accounting policies.

Related Party Disclosures

- (a) Key management personnel include those persons having authority and responsibility for planning, directing and controlling the activities of the Company as a whole. The Company has determined that key management personnel consists of members of the Company's Board of Directors and executive officers.

(ii) During Q1/2021 the Company incurred a total of \$10,800 (Q1/2020 - \$12,350) by Chase Management Ltd. ("Chase"), a private corporation owned by Mr. DeMare, for accounting and administration services provided by Chase personnel, excluding Mr. DeMare. As at February 28, 2021 \$5,000 (November 30, 2020 - \$6,500) remained unpaid.

During Q1/2021 the Company recorded \$137,495 share-based compensation for share options, DSUs and RSUs granted to Chase. During Q1/2020 the Company recorded \$5,088 share-based compensation for 250,000 DSUs granted to Chase.

(b) The Company has made ongoing advances to Rockshield Opportunities Corp. ("Rockshield Opportunities") a company which was initially incorporated as a wholly-owned subsidiary of the Company and of which its common shares were subsequently distributed to the Company shareholders. Certain of the Company's

directors remain as directors of Rockshield Opportunities. The advances are non-interest bearing and repayable on demand.

Outstanding Share Data

On February 26, 2021 the Company adopted a new stock option plan (the "Options") and converted its deferred share unit plan (the "DSUs") to a restricted share unit plan (the "RSUs"). The revised plans include 10% rolling Options and RSUs that better align the Company's directors, officers, advisors, and consultants. The Company has granted 7,700,000 Options and 8,900,000 RSUs under the plans.

The Company's authorized share capital is unlimited common shares without par value. As at April 29, 2021 there were 89,470,687 issued and outstanding common shares and 43,350,333 warrants outstanding at an exercise price of \$0.15 per share and expiring January 15, 2023. In addition, the Company has 7,700,000 share options outstanding, exercisable at \$0.56 per share and expiring February 26, 2026, and 8,900,000 RSUs outstanding expiring February 26, 2023.
