HVAC UNIT ARRIVES IN NOVA SCOTIA FOR INSTALLATION

April 17th, 2015 – Toronto, Ontario – Matica Enterprises Inc. We anticipate that installation and testing of the HVAC will take from two to three weeks. Once the final preparations for completion of the facility are made, the company will be requesting an inspection date from Health Canada shortly thereafter.

Its arrival signals the final stage of construction and brings us one step away from the pre-licence inspection by Health Canada."
