MATICA ENGAGES ICORE AS GENERAL CONTRACTOR FOR HEMMINGFORD GREENHOUSE PROJECT

August 12, 2019 – Toronto, Ontario – Matica Enterprises Inc. (MMJ – CSE) (MMJFF – OTCQB) (39N – Frankfurt) ("Matica" or the "Company") is pleased to announce that the Company has engaged Groupe Icore as general contractors to manage the construction of the Company's greenhouse project in the township of Hemmingford, Quebec.
