ALS Investments, LLC ("**ALS**") was incorporated under the laws of the State of Wyoming, and its principal business is acting as an investment holdings company.

On December 20, 2019, ALS acquired 11,823,460 Shares of the Issuer in exchange for 3,525 shares of WPD Pharmaceuticals Sp. Z.o.o. ("**WPD**") held by ALS (the "**Transaction**"). The Transaction was completed pursuant to a share exchange agreement dated July 17, 2019, as amended on November 25, 2019, among the Issuer, WPD and the securityholders of WPD (including ALS). Pursuant to the Transaction, among other things, securityholders of WPD received approximately 3,386 Shares in exchange for each security of WPD held by such securityholder immediately prior to the effective time of the Transaction.
