To consider, and, if deemed appropriate, to pass, without or without variation, the ordinary resolutions of the Shareholders set out in the Circular, approving, among other things, that certain deed of assignment between the Corporation's wholly owned Nigerian subsidiary and Bicta Energy & Management Systems Limited ("**Bicta**") dated March 9, 2012, transferring a 47% interest in the Ogedeh Marginal Field within OML-90 (the "**Ogedeh Project**") to the Corporation, along with a joint operating agreement with Bicta made as of May 28, 2012 for operating the Ogedeh Project, and the resulting change of business of the Corporation. To consider and, if deemed appropriate, to pass, with or without variation, the ordinary resolutions of the Shareholders set out in the Circular approving the amendment of the Corporation's 2008 Stock Option Plan (the "**Stock Option Plan**") from a "rolling" plan to a "fixed number" plan, the increase in the number of Common Shares available for issuance pursuant to the Stock Option Plan, and the approval and ratification of all prior grants of stock options.
