

MANAGEMENT'S DISCUSSION AND ANALYSIS

FOR THE THREE AND SIX MONTHS ENDED JUNE 30, 2024 AND 2023

INTRODUCTION

The Management's Discussion and Analysis ("MD&A") of James Bay Resources Limited (the "Company" or "James Bay") for the period ended June 30, 2024 should be read in conjunction with the Company's consolidated audited financial statements for the years ended December 31, 2023 and 2022. Those financial statements are prepared in accordance with International Financial Reporting Standards ("IFRS") and all amounts shown in this MD&A and in the financial statements are expressed in Canadian dollars, unless otherwise noted. This MD&A was reviewed and approved by the Company's Audit Committee and Board of Directors on August 13, 2024.

FORWARD-LOOKING INFORMATION

This MD&A contains certain forward-looking statements and information relating to the Company that are based on the beliefs of its management as well as assumptions made by and information currently available to the Company. COMPANY OVERVIEW

James Bay is a junior resource company originally focused on the acquisition and exploration of base and precious metal mineral properties, with activities centered in Canada.

CORPORATE STRUCTURE

The consolidated financial statement comprises the financial statements of the Company and the following subsidiaries.

James Bay Energy Nigeria LLC, USA ("JBEN LLC")	100%

D&H Energy Nigeria Limited, Nigeria ("DHENL")	100%

JBEN LLC is a Delaware limited liability company and a wholly owned subsidiary of James Bay. JBEN LLC has been inactive for several years. Management completed the wind up JBEN LLC on February 2, 2023.

On April 5, 2023, the Company received a letter from the Corporate Affairs Commission of Nigeria (the "CAC") indicating that the commission has approved and registered the final accounts for the winding up of JBENL. JBENL was deemed to be dissolved 90 days from April 4, 2023.

On April 12, 2023, the Company received a letter from the CAC indicating that the commission has approved and registered the final accounts for the winding up of CINRL. CINRL was deemed to be dissolved 90 days from April 11, 2023.

In June 2023, the Company filed for dissolution of DHENL. On February 27, 2024, the Company received a letter from the CAC indicating that the commission has approved and registered the final accounts for the winding up of CINRL. CINRL will be deemed to be dissolved 90 days from February 27, 2024. DHENL has been dormant for many years.

As of June 30, 2024, the Company has no subsidiary companies

INVESTMENT IN CERRADO GOLD

The Company recorded a loss of \$7,470 (June 30, 2023 - \$39,743 gain) on sale of Cerrado Gold shares in the condensed interim consolidated statements of (loss) income and comprehensive (loss) income for the three-month period ended June 30, 2024.

During the period, the Company sold 90,000 shares (June 30, 2023 - 420,500 shares) for total net proceeds of \$16,600 (June 30, 2023 - \$358,881). At June 30, 2024, the fair value of the 212,000 common shares (June 30, 2023 - 763,000 shares) of Cerrado Gold held by the Company was \$42,400 (June 30, 2023 - \$648,550).

FOR THE THREE AND SIX MONTHS ENDED JUNE 30, 2024 AND 2023

RESULTS OF OPERATIONS

Revenue

The Company did not have revenues from operations.

Expenses and Income

For the three months ended June 30, 2024, the Company recorded total expenses of \$119,533 (June 30, 2023 – \$316,077). The change is mainly due to a decrease in professional fees and management fees. The Company is party to legal proceedings in the ordinary course of its operations related to legally binding agreements with third parties. The trial for the claim made by the Company against Mak Mera Nigeria Nigeria Limited and Wale Sola concluded in 2023, and the judge released her decision at the end of 2023. Thus, professional fees decreased to \$58,889 (June 30, 2023 – \$168,065). Management fees also decreased to \$41,937 (June 30, 2023 – \$104,994). Effective July 1, 2023, the President and CEO stop taking a salary from the Company.

Year-to-date expenses at June 30, 2024 was \$301,642 (June 30, 2023 - \$742,387) from operations, reflecting a decrease of \$440,745 from the same period in 2023. As mentioned above, the decrease is attributable to the decrease in professional fees (\$117,042) and management fees (\$112,437) as compared to \$454,265 and \$207,128 respectively in the comparative period.

Net loss and comprehensive loss

For the three months ended June 30, 2024, the Company recorded a net loss of 132,675 (June 30, 2023 - 278,819), reflecting a decrease of approximately 146,140. This is mainly from the decrease in professional fees and management fees.

Year-to-date net loss was \$501,962 (June 30, 2023 - \$802,520) from operations, reflecting a decrease of \$300,558 from the same period in 2023.

CASH FLOWS

Operating Activities

For the period ended June 30, 2024, the Company had net cash outflow of \$249,997 (June 30, 2023 - \$818,632) from operating activities. Net cash used in operating activities decreased mainly from the decrease in professional and management fees. The Company's net change in non-cash working capital was an inflow of \$24,392 as compared to \$103,345 cash outflow for the same period in 2023.

Investing Activities

For the period ended June 30, 2024, the Company had a net cash inflow from proceeds on the sale of Cerrado Gold shares of \$113,671 (June 30, 2023 - \$723,265). The Company used these funds to finance working capital of the Company.

Financing Activities

For the period ended June 30, 2024, the Company had a net cash inflow of \$129,475 (June 30, 2023 - \$129,286) from financing activities. The Company received \$175,000 proceeds from convertible debentures as of June 30, 2024. This is offset by the repayment of shareholder loans (\$25,000), and lease payments on the premise (\$20,525).

As at June 30, 2024, the Company had no source of operating cash flows. The Company reported a net loss and other comprehensive loss of \$501,962 and a deficit of \$20,881,278. The Company's continuance as a going concern is dependent upon its ability to obtain equity capital and financing for its working capital.

The Company's opinion concerning liquidity and its ability to avail itself in the future of the financing options mentioned above are based on currently available information. To the extent that this information proves to be inaccurate, future availability of financing may be adversely affected. Factors that could affect the availability of financing include the Company's performance (as measured by various factors including the progress and results of its exploration work) and equity markets, investor perceptions and expectations of past and future performance, the global financial climate.

CAPITAL RESOURCES

Common shares

At June 30, 2024 and August 13, 2024, the Company had 81,076,241 common shares issued and outstanding.

Stock options

At June 30, 2024 and August 13, 2024, the Company had 5,000,000 stock options issued and outstanding.

Warrants

There are no warrants outstanding at June 30, 2024 and August 13, 2024.

FINANCIAL INSTRUMENTS

The Company's risk exposures and the impact on the Company's financial instruments are summarized below. There have been no significant changes in the risks, objectives, policies and procedures from the previous period.

Credit risk

The Company's credit risk is primarily attributable to cash and cash equivalents and amounts receivable. The Company has no significant concentration of credit risk arising from operations. Management believes that the credit risk concentration with respect to cash and cash equivalents and amounts receivable is remote.

Liquidity risk

The Company's approach to managing liquidity risk is to ensure that it will have liquidity to meet liabilities when due. At June 30, 2024, the Company had cash of \$10,914 (December 31, 2023 - \$17,765) to settle current liabilities of \$421,609 (December 31, 2023 - \$938,650). The Company had a working capital deficiency of \$1,042,034 (December 31, 2023 - \$545,363). The Company's current financial liabilities generally have contractual maturities of less than 30 days and are subject to normal trade terms.

Market risk Interest rate risk

The Company has cash balances. The Company's current policy is to invest excess cash in investment-grade short-term guaranteed investment certificates issued by its banking institutions. The Company periodically monitors the investments it makes and is satisfied with the credit ratings of its banks.

Fair value

The carrying value of cash, amounts receivable, CEBA loan, shareholder loan, accounts payable and accrued liabilities approximate their fair value due to the relatively short periods to maturity of the financial instruments. The carrying value of the convertible debentures is equal to its fair value.

Fair value hierarchy and liquidity risk disclosure

Fair value measurements are classified using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy shall have the following levels: (a) quoted prices (unadjusted) in active markets for identical assets or liabilities (Level 1); (b) inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices) (Level 2); and (c) inputs for the asset or liability that are not based on observable market data (unobservable inputs) (Level 3).

RELATED PARTY DISCLOSURES

During the period ended June 30, 2024, \$53,101.67 (December 31, 2023 - \$114,977) was charged by a law firm of which a partner is a director of the Company. As of June 30, 2024, included in accounts payable and accrued liabilities is an accumulated balance of approximately \$84,125 (December 31, 2023 - \$35,517) owing to this law firm.

In accordance with IAS 24, key management personnel are those having authority and responsibility for planning, directing and controlling the activities of the Company directly or indirectly, including any directors (executive and non-executive) of the Company.

During the period ended June 30, 2024, the Company paid \$18,000 to an officer. In July 2023, the Company issued 12,000,000 common shares at a deemed price of \$0.05 per share to the President and CEO as full and final payment of debt in the aggregate amount of \$600,000. The 12 million shares issuable to the Company's CEO, for amounts owing to him as part of the Debt Settlement will be held in escrow and only released upon James Bay entering into an agreement to acquire an active business. As of June 30, 2024, included in accounts payable and accrued liabilities is a balance of \$89,344 (December 31, 2023 - \$89,344) owing to two executive officers.

In July 2023, the Company issued 2,700,000 common shares at a deemed price of \$0.05 per share to the directors as full and final payment of directors' fees debt in the aggregate amount of \$135,000, for directors' fees owing from April 1, 2021 to June 30, 2023. As of June 30, 2024, included in accounts payable and accrued liabilities is an accumulated directors' fees accrual of \$60,000 for the period from July 1, 2023 to June 30, 2024.

CONVERTIBLE DEBENTURES

Beginning in December 2023 and through the period ending March 31, 2024, the Company recorded \$300,000 in aggregate principal amount of convertible debentures. Of which, \$50,000 advanced but not yet closed, pending completion of "round 2." The convertible debentures bear interest of 15% per annum, payable semi-annually and mature three years following the date of issuance. The convertible debentures are convertible at a conversion price of \$0.05 per common share.

In April 2023, the Company initiated a negligence claim against the lawyer who acted for CB Holdings and related companies in relation to the US\$3.5M loans made by James Bay in 2018, seeking damages incurred from the lawyer's negligent conduct. The claim has been filed in California and has been served on the defendants (the "California Litigation").

James Bay has made legal filings in April 2023 to pursue 1782 disclosure under Nevada law from Wynn Casinos in Nevada, in efforts to obtain evidence to substantiate the claim that Wynn Casinos did not properly fulfill its duty to know your client and to properly investigate sources of funding from designated guests spending excessively at the casinos and other facilities extensively (the "Nevada Litigation"). The California Litigation and the Nevada Litigation, collectively the "Litigation".

The Company concurrently sold and assigned, pursuant to separate agreements with each subscriber, a pro rata entitlement (based on all the subscribers) for up to an aggregate of 30% of the net proceeds of the Litigation, if any (whether as a result of final judgement by a court of competent jurisdiction or settlement for which no appeal or further proceeding may be taken (the "Final Award")), after deduction of all related costs and taxes incurred by the Company in the Litigation (the "Net Final Amount"), for the initial 1 Million of Net Final Amount and 20% of any Net Final Amount above \$1,000,000 payable to the Holders within 60 days from the receipt of the Final Award. In the event the Company prepays the Debentures in full prior to that date which is one year from the date of issue and prior to the date of the Final Award, then the amount payable to the Holders under the agreement will be adjusted to reflect an aggregate entitlement of 15%. Should the Company's litigation be settled or be the subject of a final decision and if the Company is in receipt of settlement funds, the convertible debentures holders written notice to the Company.

The President and CEO of the Company purchased an aggregate of \$50,000 of convertible debentures. Two Directors of the Company purchased an aggregate of \$100,000 of convertible debentures.

In accordance with IFRS, the entire instrument is treated as a liability and the conversion option is revalued every reporting period. The net present value of the liability component of the convertible debentures has been estimated using an effective interest rate of 27.2%. The directly attributable transaction costs were expense in the consolidated statements of loss and comprehensive loss. The convertible debentures, net of transaction costs, are accreted such that carrying amount of the convertible debenture will equal the face value of the convertible debenture at maturity. The accretion on the convertible debentures is included in interest expense in the consolidated statements of loss and comprehensive loss.

The rate of 27.2% was used in estimating the value of the liability component of the convertible debentures and used to apply the effective interest rate method to the convertible debentures is based on significant management estimation.

COMMITMENTS AND CONTINGENCIES

The Company is party to certain management contracts, which contain clauses requiring additional payments of up to \$864,000 be made upon the occurrence of certain events such as a change of control and additional payments of up to \$872,000 be made upon termination of contracts. As a triggering event has not taken place, the contingent payments have not been reflected in these consolidated financial statements. As of March 31, 2024, under these management contracts, management has committed to \$522,000 of salaries and benefits due within one year.

On April 24, 2024, the Company announced that it has received a costs award from the decision of Justice Papageorgiou (the "Decision") of the Ontario Superior Court of Justice, in the claim made by James Bay against Mak Mera Nigeria Limited ("Mak Mera") and Wale Sola. Under the Decision, James Bay was successful in all claims, and was awarded \$405,000 to be repaid by Mak Mera, plus \$200,000 in damages for defamation against Mak Mera and Wale Sola, jointly and severally.

James Bay was awarded costs of approximately \$309,402, solely against Mak Mera. Costs were not awarded against Mr. Wale Sola personally, as Justice Papageorgiou determined that there was divided success in the Decision concerning the issues between Mr. Sola and James Bay.

Mak Mera and Wale Sola are appealing the Decision and the costs awarded. The date to hear the appeal has not yet been set.

OFF BALANCE SHEET ARRANGEMENTS

The Company has no off-balance sheet arrangements.

RISKS AND UNCERTAINTIES

Additional Capital

The Company conducted due diligence to identify potential project. If the results are favourable, Company will require additional capital which may come from future financings. There can be no assurance that the Company will be able to raise such additional capital if and when required on terms it considers acceptable.

No History of Profitability

The Company is an exploration company with no history of profitability. There can be no assurance that the operations of the Company will be profitable in the future. The Company has limited financial resources and will require additional financing to further explore, develop, acquire, retain and engage in commercial production on its property interests and, if financing is unavailable for any reason, the Company may become unable to acquire and retain its mineral concessions and carry out its business plan.

Conflicts of Interest

Certain of the directors and officers of the Company may also serve as director and officer of other companies involved in gold and precious metal or other natural resource exploration and development and consequently, the possibility of conflict exists. Any decisions made by such directors involving the Company will be made in accordance with the duties and obligations of directors to deal fairly and in good faith with the Company and such other companies. In addition, such directors declare, and refrain from voting on any matters in which such directors may have a conflict of interest.
