



Caza Gold Shareholders Approve All Resolutions at AGM

Vancouver, Canada – June 19, 2015 – Brian Arkell, CEO and President of Caza Gold Corp. (CZY: TSX-V, CZ6: FSE), is pleased to announce that the Company completed its Annual General Meeting on June 16, 2015 and all resolutions at the AGM were approved.

Messrs. Mike Humphries, Mike Adams, Jim Defer, Stewart Lockwood and Philip Yee were re-elected to the Board of Directors for the ensuing year, and Mr. Brian Arkell, President and CEO of the Company, was elected to the Board of Directors. The Board of Directors re-appointed Mr. Brian Arkell as CEO and President, Mr. Marco Montecinos as Vice-President of Exploration and Mr. Philip Yee as CFO and Vice-President (Finance).

Disinterested shareholders voted in favor for the compensation of US\$100,000 per annum payable in common shares of the Company, pursuant to the Consultant Agreement with Mr. Brian Arkell for his provision of President and CEO services to the Company. In addition, shareholders voted in favor of the Company's rolling stock option plan.

About Caza Gold Corp.

Caza Gold Corp. is a greenfields exploration company focused on discovering new gold deposits in Nicaragua. The Company controls a large land position in the highly prospective but largely undeveloped gold belts of Nicaragua. Caza has developed a large portfolio of projects in Nicaragua, including the Los Andes gold-silver project and the Piedra Iman copper-gold project.

Caza controls over 750 square kilometers of prospective ground within the central Nicaragua Gold Belt. In addition to the Los Andes Gold Project, Caza is exploring the Piedra Iman porphyry in northern Nicaragua along with five high-sulfidation volcanic hosted Au-Ag targets located in west-central Nicaragua near the Pan-American Highway.
