On March 31, 2020, the Acquirer entered into a loan agreement with the Issuer (the "**Loan Agreement**") whereby the Acquiror agreed to advance an initial amount of USD\$127,000 and upon request from the Issuer a possible further USD\$297,000 (collectively the "**Advances**") on or before December 31, 2021 (the "**Transaction**"). Pursuant to the terms of the Loan Agreement the Acquiror will be issued a second ranking secured convertible promissory note in the initial amount of USD\$127,000, convertible into Common Shares of the Issuer at the market price of the shares at the time of conversion.

Immediately prior to the execution of the Loan Agreement, the Acquiror had ownership and control over a total of 37,523,574 common shares of the Issuer, representing 28.72% of the issued and outstanding common shares. Assuming a conversion by the Acquiror of all of the amounts owing or potentially owing under the Loan Agreement, using a Bank of Canada exchange rate on March 27, 2020 and a conversion price for all amounts under the Loan Agreement of C\$0.09 per share being the trading price of the Common Shares on close of business day immediately prior to the entering of the Loan Agreement, the Acquiror would acquire ownership and control over a total of 6,621,937 common shares of the Issuer, representing 4.82% of the issued and outstanding common shares. Immediately following such conversion of convertible securities of the Issuer held by the Acquiror and assuming conversion of convertible securities of the Issuer held by the Acquiror, the Acquiror would have ownership and control over 60,215,505 common shares of the Issuer, representing 35.54% of the issued and outstanding Common Shares on a partially diluted basis.
