On November 29, 2022, Mr. Rowe acquired (the "**Acquisition**") an aggregate of 6,386,363 common shares (the "**Common Shares**") in the capital of the Company purchased in the Company's private placement of Common Shares at a price of \$0.022 per Common Share.

Additionally, Mr. Rowe has also acquired the following Common Shares in recent months:

- (i) on September 30, 2022, Mr. Rowe acquired an aggregate of 1,431,034 Common Shares in the capital of the Company at a price of \$0.04 per Common Share; and
- (ii) on October 13, 2022, Mr. Rowe acquired an aggregate of 1,945,000 Common Shares in the capital of the Company at a price of \$0.02 per Common Share.

Prior to the completion of the Acquisition, Mr. Rowe beneficially owned and controlled, directly or indirectly, an aggregate of 57,261,818 Common Shares, 5,060,000 stock options and 13,796,863 common share purchase warrants, representing approximately 43.83% of the Company's issued and outstanding Common Shares on an undiluted basis and approximately 58.26% on a fully diluted basis. Following the completion of the Acquisition, Mr. Rowe beneficially owns and controls, an aggregate of 63,648,181 Common Shares, 5,060,000 stock options and 13,796,863 common share purchase warrants, representing approximately 45.55% of the Company's issued and outstanding Common Shares on an undiluted basis and approximately 59.04% on a fully diluted basis.
