The Creditor acquired an aggregate of \$77,267.41 principal amount of convertible debentures ("**Debenture**") and 772,674 common share purchase warrants ("**Warrants**") on July 14, 2020. The principal amount of the Debentures will be repaid, in cash, by the Issuer on the third anniversary of issuance ("**Maturity**") and will carry an interest rate of 12% per year compounded monthly and payable at Maturity. Subject to receipt of shareholder approval, the Debentures are convertible into common shares of the Company at \$0.05 per share for the first year the Debentures are outstanding and at \$0.10 per share thereafter. Subject to receipt of shareholder approval, each Warrant is exercisable into one Common Share at an exercise price of \$0.10 per Common Share for a period of three years from the date of issuance. Shareholder approval was obtained on November 10, 2020.

The Creditor acquired \$77,267.41 principal amount of Debentures, which are convertible into an aggregate of 1,545,348 Common Shares in the first year the Debentures are outstanding, which represents 8.9% of the Common Shares on a partially diluted basis. In addition, the Creditor acquired an aggregate of 772,674 Warrants, which are convertible into an aggregate

of 772,674 Common Shares, which represents 4.6% of the Common Shares on a partially diluted basis.
