On June 1, 2022, the Company announced that it has consolidated its issued and outstanding share capital on the basis of one post-consolidated Common Share for every 500 pre-consolidated Common Shares (the "Consolidation"). Following the Consolidation, the Acquiror's securityholding was consolidated to 153,974 post-Consolidation Common Shares and 20,000 post-Consolidation Warrants.

On June 21, 2022, the Acquiror surrendered 20,000 post-Consolidation Warrants to the Company for cancellation.

On June 29, 2022, the Acquiror acquired 1,688,500 Common Shares at a price of \$0.02 per share for the total price of \$33,770 by way of a private placement.

Subsequent to these changes and as a result of the increase in the issued and oustanding shares of the Company due to the closing of a private placement, the Acquiror's holding of Common Shares decreased to below 10% of the issued and outstanding shares of the Company.
