Glen Eagle disposed of an aggregate number of 163,500 Shares (the "**Shares**") via public market. Of these Shares, 146,000 Shares were disposed on April 25, 10,000 Shares were disposed on April 27 and 7,500 Shares were disposed on April 28, 2023 (collectively, the "**Disposition**").
